

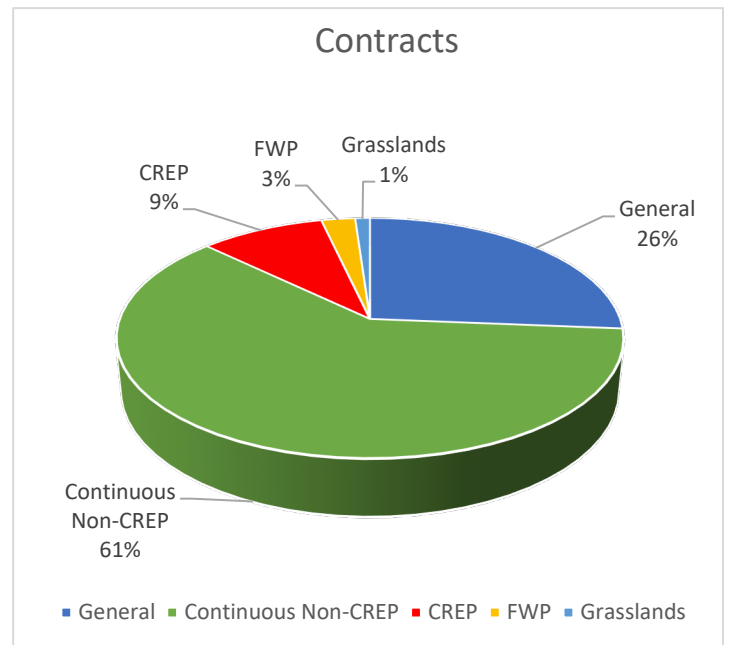
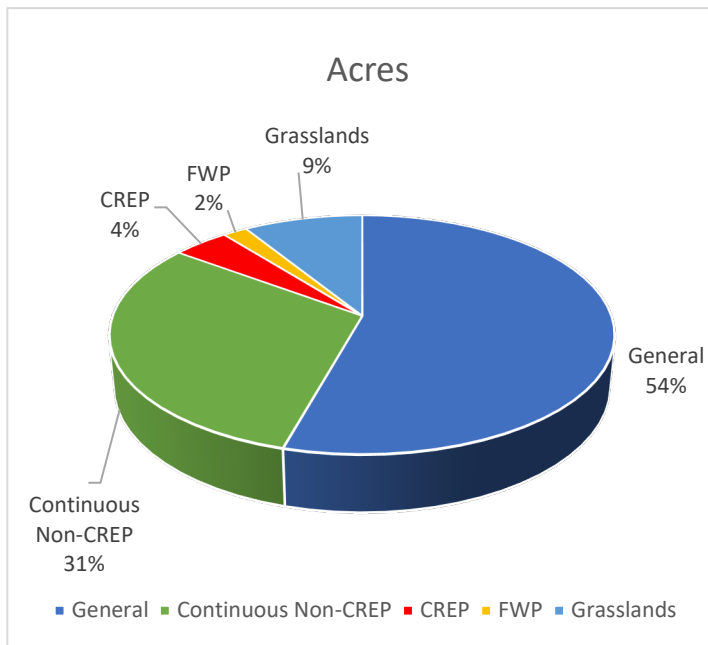

General Signup. Producers with eligible lands compete nationally for acceptance based on an environmental benefits index (EBI) during specified enrollment periods. Producers may submit offers below soil-specific maximum rental rates and select wildlife-enhancing vegetative covers to increase EBI ranking.

Continuous (Non-CREP) Sign-up. Producers with eligible lands may enroll certain high priority conservation practices, such as filter strips, riparian buffers, and wetlands at any time during the year without competition. In addition to annual soil rental payment and cost-share assistance, many practices are eligible for additional annual and one-time up-front financial incentives.

Conservation Reserve Enhancement Program (CREP). Under CREP, federal funds are supplemented with non-federal funds from eligible partners to implement projects designed to address specific environmental objectives through targeted CRP enrollment. Eligible partners provide matching contributions such as cash, in-kind contributions, or technical assistance. Eligible producers may enroll eligible land any time during the year.

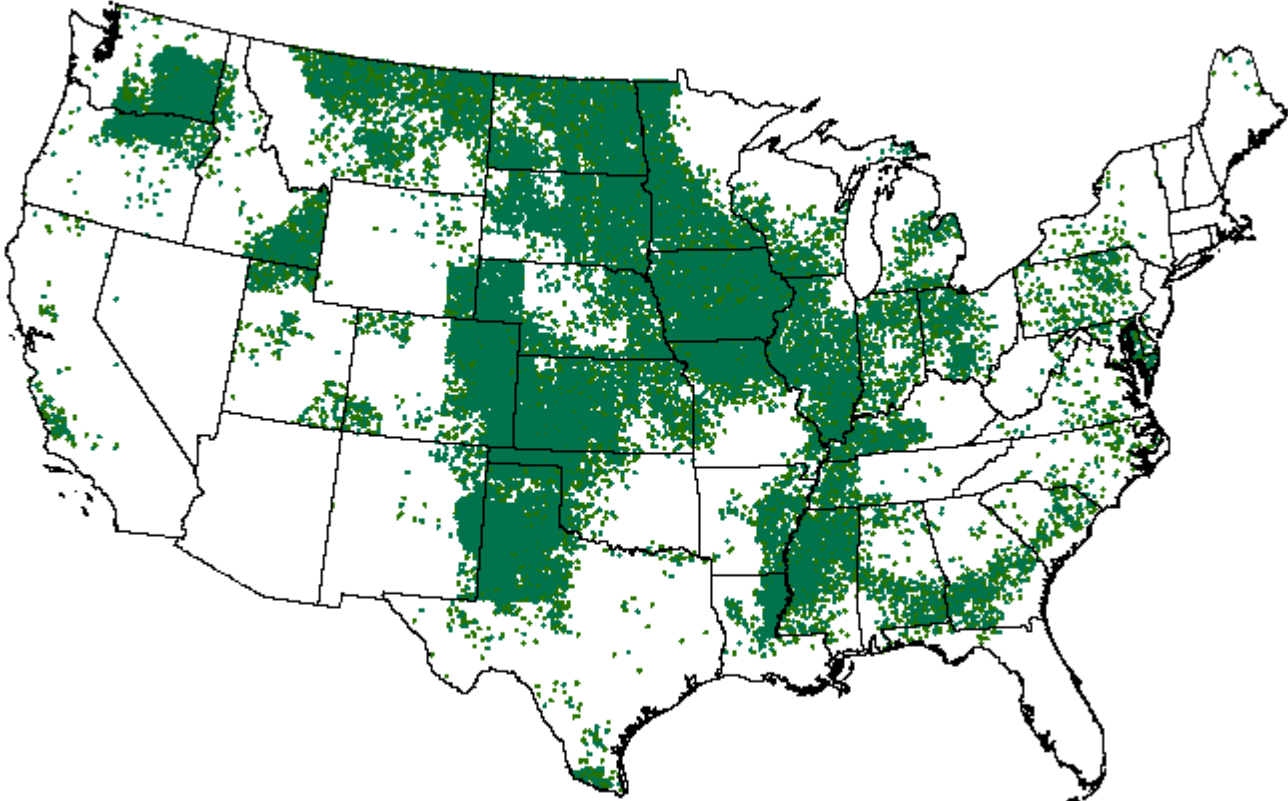
Farmable Wetland Program (FWP). Producers enroll small non-flood plain wetlands, and new practices added by the 2008 Farm Bill, under modified continuous sign-up provisions.

Grasslands. Enrollments are to support grazing operations and to preserve and restore grasslands. No cropping history is required.

The accompanying tables are based on contract data developed and maintained in CRP data files by USDA Service Centers through the **end of September** and are based on the physical location of the CRP contracted land. Some adjustments have been made to correct miscoded data in the active contract files.

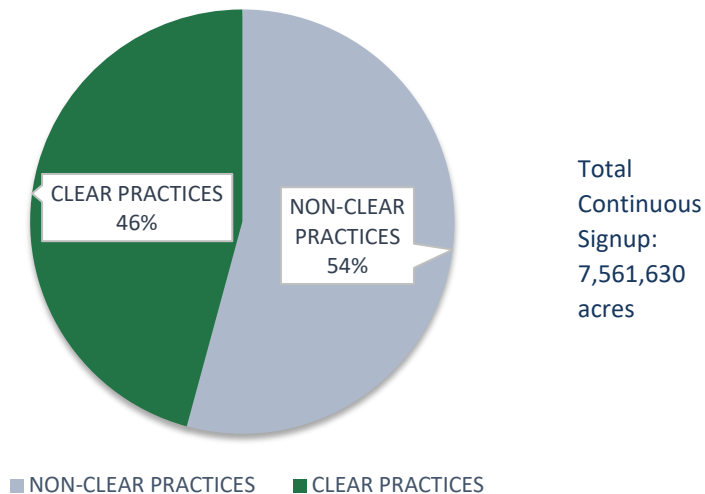

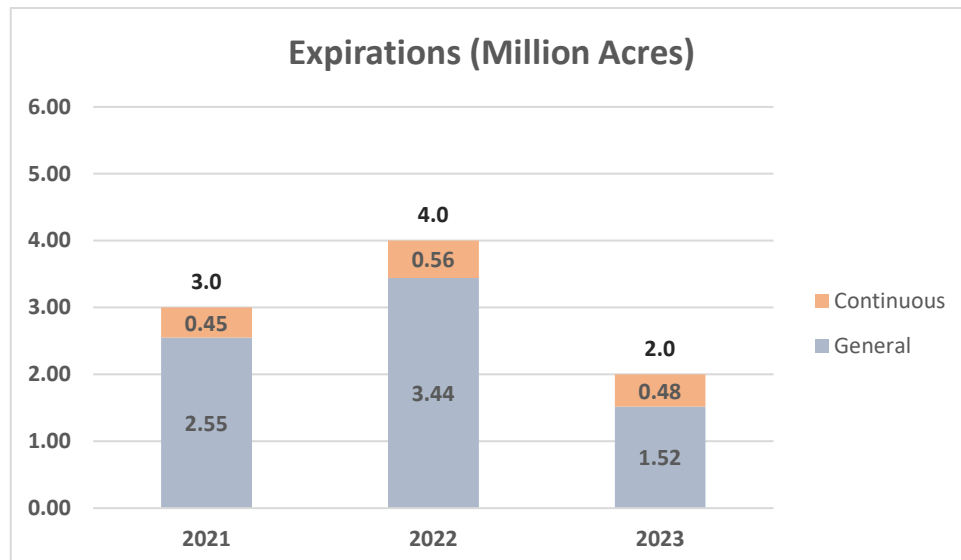

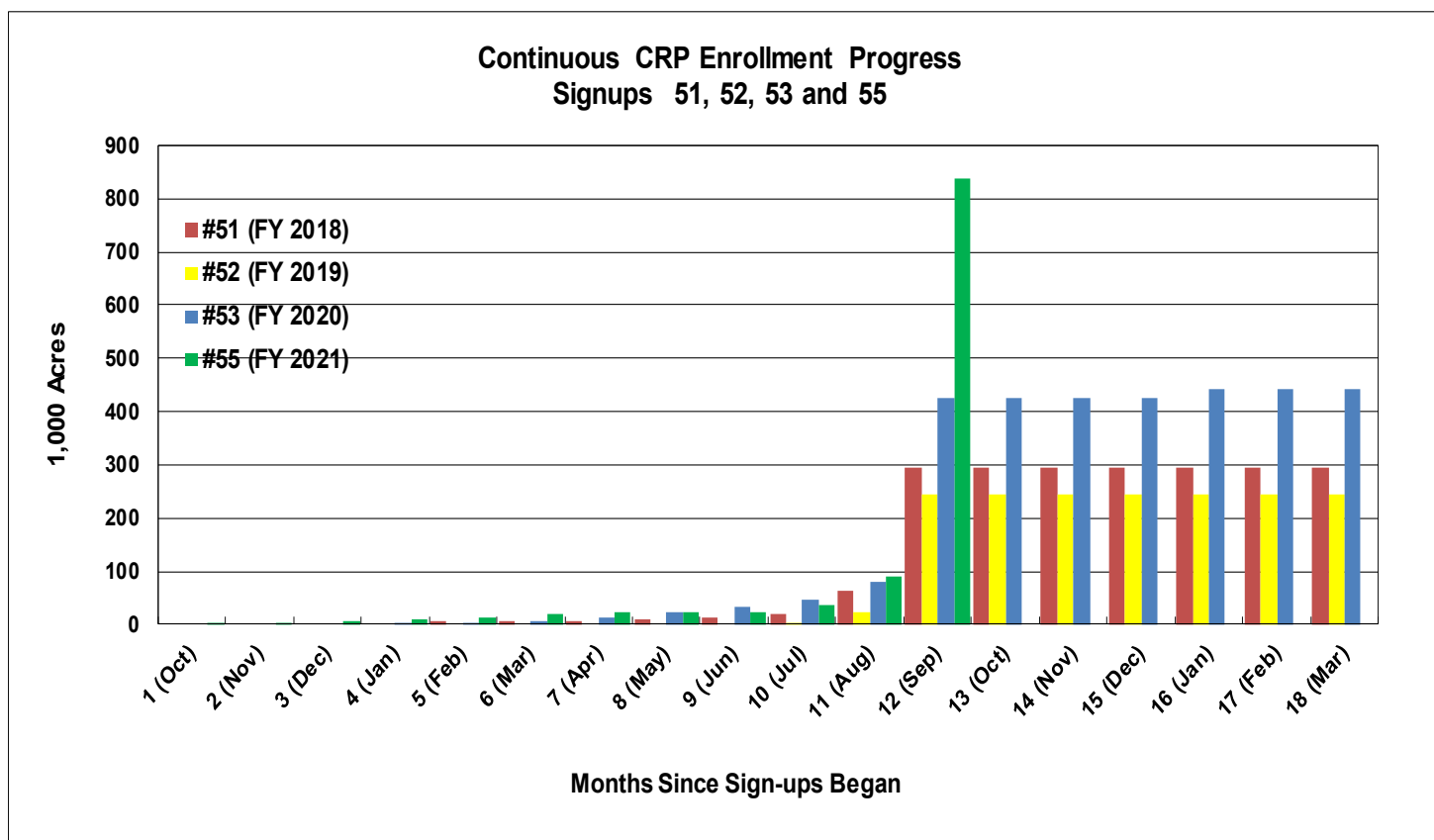

CONSERVATION RESERVE PROGRAM

ENROLLMENT ACTIVITY AND NEWS – SEPTEMBER 2021

- Enrollment ends September 2021 at 20.5 million acres.
- FY 2021 continuous (#55) signup opened October 1 and closed September 30.
- On April 21, 2021, Secretary Vilsack announced changes to CRP including higher payment rates, new incentives, and a more targeted focus on the program’s role in climate change mitigation. These changes went into effect mid-June 2021.
- General signup (#56) opened on January 4, 2021 and closed July 23, 2021. More than 2 million acres were offered for enrollment, and almost 1.9 million acres were accepted. These contracts will be effective on October 1, 2021.
- Grasslands signup (#203) was open from July 12 through August 20, 2021. There were 2.5 million acres accepted, which is double last year’s enrollment. Submitted offers were made on nearly 4 million acres, the highest in grasslands history. These contracts will be effective on October 1, 2021.
- A signup period for the Soil Health and Income Protection Program (SHIPP) pilot ran from May 10 through July 30, 2021.
