FY 2000 allocations of direct and guaranteed farm ownership and operating loans for individual States have been computed according to FmHA Instruction 1940-L. Individual State allocations are in Exhibit 1.

2 Loan Programs Not Funded or Not Allocated to States

A Programs Not Funded

The following Farm Loan Programs are not funded in FY 2000:

- Grazing Association
 - Guaranteed Farm Ownership With Interest Assistance
 - Irrigation and Drainage
 - Direct Soil and Water
 - Guaranteed Soil and Water
 - Credit Sales and Acquired Properties.

B Programs Not Allocated to States

The following Farm Loan Programs are not allocated to States.

Emergency Loans - Loans may be obligated as loans are approved in designated areas. The FY 2000 appropriations bill (Pub. L. 106-78) provides funding authority of \$25 million. A carryover of unused funds from FY 1999 totaling \$10.9 million is also available for use in FY 2000. A supplemental appropriations bill (Pub. L. 106-113) provides an additional \$547 million.

Indian Tribal Land Acquisition Loans - Control of funds is being retained in the National Office. States shall request funds from the Director, LMD, by FAX on 202-690-1117. Funding authority for FY 2000 is \$1,028,000.

 - Guaranteed Farm Ownership (see subparagraph F).

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$1,000,000, \$500,000, \$10,000,000, and \$500,000, respectively.

An administrative allocation has been made to each State. Under the administrative allocation, each State received the same percentage of the FY 2000 allocation as the State received of the initial allocation in FY 1999.

The FY 2000 appropriations bill provides funding authority of \$500 million. A carryover of unused funds from FY 1999 totaling \$35,274,000 is also available for use in FY 2000. A supplemental appropriations bill (Pub. L. 106-113) provided an additional \$400 million.

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$400,000, \$400,000, \$3,000,000, and \$400,000, respectively.

An administrative allocation has been made to each State. Under the administrative allocation, each State received 75 percent of their FY 1999 obligations.

Funding authority provided in the FY 2000 appropriations bill is \$1,697,842,000. A carryover of unused funds from FY 1999 totaling \$121,388,000 is also available for use in FY 2000. A supplemental appropriations bill (Pub. L. 106-113) provided an additional \$302.1 million.

An administrative allocation has been made to Alaska, the Virgin Islands, and the Western Pacific Areas. The amount of the administrative allocation to each of these jurisdictions was \$300,000.

An administrative allocation has been made to each State. Under the administrative allocation, each State received its average obligations for FY 1999 and FY 1998. Each State was allotted a minimum of \$300,000.

The FY 2000 appropriations bill provides funding authority of \$200,000,000. A carryover of unused funds from FY 1999 totaling \$16,068,000 is also available for use in FY 2000. A supplemental appropriations bill (Pub. L. 106-113) provided an additional \$702.5 million.

An administrative allocation has been made to Alaska, the Virgin Islands, Puerto Rico, and the Western Pacific Areas. The amount of the administrative allocation to these jurisdictions was \$400,000, \$300,000, \$1,200,000, and \$300,000, respectively.

The FY 2000 appropriations bill provides funding authority of \$128,049,000. A carryover of unused funds from FY 1999 totaling \$27.5 million is also available for use in FY 2000. A supplemental appropriations bill (Pub. L. 106-113) provided an additional \$21.9 million.

An administrative allocation has been made to each State. Under the administrative allocation, each State received its average obligations for FY 1999 and FY 1998.

The FY 2000 appropriations bill provides funding authority of \$431,373,000. A carryover of unused funds from FY 1999 totaling \$2,446,000 is also available for use in FY 2000. A supplemental appropriations bill (Pub. L. 106-113) provided an additional \$568.6 million.
