CCC will telephone notice of acceptance by: 3:00 p.m., CDT, June 15, 2001.

Contractors will offer for the sugar in the attached exhibits, designating the specific lots in the exhibit.

Successful contractors will receive that sugar in exchange for the quantity of liquid sucrose awarded in each exhibit. Contractors must offer the full quantity of liquid sucrose at a specific location. (Example - Offer 1: 219,740 total pounds of liquid sucrose.)

In formulating the offer, the offeror should note that CCC-owned sugar will be received by the contractor instore, at storage locations specified in this Invitation under each exhibit. Delivery of the sugar by CCC shall be instore at the location specified in the contract. Contractor is entitled to the Processed Commodity Storage Agreement (PCSA) storage rate in effect at the time of wire release for a period of 60 days. Any difference between the quality and quantity surrendered by CCC and that actually delivered to the contractor by the storing warehouse shall be settled between the contractor and the storing warehouse.

Interested parties are advised to check with the storing warehouse regarding scheduling, quality, and location of refined or raw sugar. Interested parties are strongly urged to establish, prior to making an offer, the premium and discount schedules in case of quality or location discrepancies. Requesters must pay applicable charges to the storing warehouse. Commodity delivered by contractor may be processed from the sugar supplied by CCC or from other sugar produced in the United States, as specified in the announcement.

**Storage for the account of CCC shall be through the date of transfer of title as evidenced on the wire release which will occur when all proper documentation is received for each shipment period, BUT NO LATER THAN 15 BUSINESS DAYS AFTER THE LAST DAY OF THE SHIPMENT PERIOD LISTED IN THE OFFER. The contractor shall be responsible for all charges thereafter.**

Exhibits A - K contain a list of PCSA warehouse names and locations together with kind, quality and quantity of CCC-owned sugar to be exchanged.

The contractor will bid for a quantity of sugar from the attached exhibits, designating the lot, locations and quantity in exchange for the quantity of liquid sucrose specified in the offer. In formulating the offer, the offeror should note that CCC-owned sugar will be received by the contractor instore, at storage locations specified in this Invitation under the attached exhibits. The contractor must take complete lots with only one partial.

The content of an offer will include quantity and location contained in the exhibit in which the offeror is bidding. **ONLY ONE EXHIBIT PER OFFER FORM.**

CCC has the option to award less than quantity offered. Each offer will be analyzed independently. No offer will be contingent upon any other offer.

Any actual damages suffered by CCC resulting from any failure or refusal of contractor to perform, shall be for the account of the contractor. Such actual damages shall include, but not be limited to: storage and excess replacement costs.

## 8. COMMODITY SPECIFICATIONS

### Add B. Quality Specifications White Liquid Sucrose

**Color** Clear to slightly straw color (35 MAX using USNC MOA 0001)

**Percent Solids (BRIX)** 67.2 - 67.6 Using refractometer @ 20 degrees Centigrade

**Percent Invert** No more than 0.3 using Lane Eynon

**Percent Ash** MAX 0.025 using USNC MOA 0005

**Ph** 6.5 to 8.0 @ 20 degrees Centigrade

**Sucrose Percent** No less than 99.8 (dry basis)

**Micro Standards** Yeast / 10 grams solid < 10  
 Mold / 10 grams solid < 10  
 Mesophiles / 10 grams solid < 100

Using the National Soft Drink Association (NSDA) testing methods.

**Delivery Temperature** Minimum 80 degrees Farenheit / Maximum 120 degrees Farenheit

**General** Must comply with all regulations under the Federal Food Drug and Cosmetic Act, and be manufactured in accordance with Current Good Manufacturing Practices. The product shall not have a foreign taste or emit any objectionable odor in dry form or when a 10% solution is acidified to a pH of 2.5 with USP phosphoric acid and allowed to stand for 72 hours.

**Density** The weight per gallon at 67.4 brix shall be 11.10 pounds. Weight of solids will be calculated at 7.48 pounds per gallon.

### Add C. (1) Quality Assurance

- (a) The contractor must perform the product testing and quality analysis to ensure that the product analysis meets the specifications described in Section 10 B. The results must be evidenced by a Certificate of Analysis. The contractor must retain the Certificates of Analysis and furnish to USDA upon request. Contractors are required to notify KCCO immediately of lots that fail to meet contract requirements. Contractor to provide a copy of Certificate of Analysis with each shipment.
- (b) In the event a quality dispute occurs, CCC will request an independent accredited laboratory analysis be performed to resolve the dispute. The expense of this

analysis will be for the account of the contractor.

Add D. Liquidated Damages

Compensation to USDA for Delay in Delivery

Liquidated damages for delay in delivery will be payable in accordance with Article 67 of USDA-1, and will be at the rate of \$0.10 per 100 pounds (net weight) per day.
