## WEEKLY WOOL NATIONAL MARKET PRICE

Washington, February 11, 2014 - The U.S. Department of Agriculture's Commodity Credit Corporation today announced the national posted prices for wool. The effective repayment rate is the lower of either the 30-day average or weekly rate.
