AVAILABLE FARM LOANS

Farm Operating and Farm Ownership Loans:

FSA makes direct and guaranteed farm ownership (FO) and operating loans (OL) to family-size farmers and ranchers who cannot obtain commercial credit from a bank, Farm Credit System institution, or other lender. FSA loans can be used to purchase land, livestock, equipment, feed, seed, and supplies. Our loans can also be used to construct buildings or make farm improvements.

Beginning Farmer Program:

Each fiscal year, FSA targets a portion of its direct and guaranteed farm ownership (FO) and operating loan (OL) funds to beginning farmers. A beginning farmer is an individual or entity who (1) has not operated a farm for more than 10 years; (2) meets the loan eligibility requirements of the program to which he/she is applying; (3) substantially participates in the operation; and, (4) for FO purposes, does not own a farm greater than 30 percent of the median size farm in the county. (Note: all applicants for direct FO loans must have participated in the business operation of a farm for at least 3 years.)

Loans for Socially Disadvantaged Persons:

Each fiscal year, FSA targets a portion of its direct and guaranteed farm ownership (FO) and operating loan (OL) funds to SDA farmers. Non-reserved funds can also be used by SDA persons. An SDA group is a group whose members have been subject to racial, ethnic or gender prejudice because of their identity as members of a group without regard to their individual qualities. These groups consist of American Indians or Alaskan Natives, Asians, Blacks or African Americans, Native Hawaiians or other Pacific Islanders, Hispanics and women.

Youth Loans:

FSA makes operating loans of up to \$5,000 to eligible individual rural youths age 10 through 20 to finance income-producing, agriculture-related projects. The project must be of modest size, educational, and initiated, developed and carried out by rural youths participating in 4-H clubs, FFA or a similar organization. The project must be an organized and supervised program of work. It must be planned and operated with the assistance of the organization advisor, produce sufficient income to repay the loan, and provide the youth with practical business and educational experience in agriculture-related skills.

Emergency Loans:

FSA provides emergency loans to help producers recover from production and physical losses due to drought, flooding, other natural disasters, or quarantine. Emergency loan funds may be used to: restore or replace essential property; pay all or part of production costs associated with the disaster year; pay essential family living expenses; reorganize the farming operation; and refinance certain debts. To apply for an emergency loan, you must have owned or operated land located in a county declared by

the President as a disaster area or designated by the Secretary of Agriculture as a disaster area or quarantine area.

Conservation Loans:

CL funds can be used to implement conservation practices approved by the Natural Resources Conservation Service (NRCS), such as the installation of conservation structures; establishment of forest cover; installation of water conservation measures; establishment or improvement of permanent pastures; implementation of manure management; and the adaptation of other emerging or existing conservation practices, techniques or technologies.

IRS FORM 1099-G

Producers annually receive CCC-1099-Gs detailing payments producers have received from the Commodity Credit Corporation. The annual report of program payments on CCC-1099-Gs is a service intended to help our customers report taxable income. It is not intended to replace the producers' responsibilities to report income to IRS. FSA staff cannot interpret IRS regulations or advise producers about which payments to report on their income tax returns. However, county office staff can review payments for accuracy.

MAINTAINING THE QUALITY OF LOANED GRAIN

This year's large grain crop has its obvious up side, but there is a downside too. Many producers are hard pressed to find adequate storage for every bushel harvested. Overfilled grain storage bins can lead to grain quality problems.

Bins are ideally designed to hold a level volume of grain. When bins are overfilled and grain is heaped up, airflow is hindered and the chance of spoilage increases.

Producers who take out marketing assistance loans and use the farmstored grain as collateral should remember that they are responsible for maintaining the quality of the grain through the term of the loan.

NAP CLARIFICATIONS

There has been some confusion on the filing deadlines for the Noninsurable Crop Disaster Assistance Program (NAP). Signed and dated crop production must be filed no later than the immediately subsequent crop year acreage reporting deadline for that crop. Also, production cannot be accepted without an acreage report.

For Example:

Farmer John timely purchased 2011 NAP on his 100 acres of pistachios. He must file an acreage report (also known as crop certification) by July 15, 2011. When his 2011 crop is harvested, he must file his production by July 15, 2012. If he forgets to file an acreage report, his crop production will not be accepted.

Failure to timely file acreage reports and production could result in future ineligibility for NAP assistance on that crop.

DCP SIGN-UP UNDERWAY

Signup has started for the 2011 Direct & Countercyclical Payment (DCP) Program for farms with base acres. Signup will continue until June 1, 2011. The June 1, 2011 deadline is mandatory for all participants. FSA will not accept any late-filed applications.

FSA computes DCP Program Payments using base acres and payment yields established for each farm. Eligible producers receive direct payments at rates established by statute regardless of market prices. For 2011, producers may request to receive advance payments no earlier than December 2010 based on 22 percent of the direct payment for each commodity associated with the farm. Counter-cyclical payment rates vary depending on market prices and are issued only when the effective price for a commodity is statutorily set below its target price.


COC ELECTION RESULTS

Please note: Some FSA programs require ALL crops to be insured with either CAT or NAP.
