### <u>LOW-DOC OPERATING</u> <u>LOANS AVAILABLE</u>

Low-Documentation The Operating Loan is made to eligible applicants based on reduced documentation or paperwork. Lo-Doc loans are available to producers with operating loan requests of \$50,000 or less (as long as their total FSA debt will not exceed \$100,000 at the time of loan closing) or to existing FSA borrowers who have made timely payments for at least two previous annual operating loans with FSA.

Prospective applicants must be current on all payments to all creditors and must not have received primary loan servicing on any FSA debt within the last five years.

## LAA-1 COUNTY COMMITTEE ELECTION

Nominations for candidates to run for the Farm Service Agency County Committee (COC) election representing producers Local Administrative Area (LAA) 1 (Rumsey, Guinda, Brooks, Capay, Esparto, Madison and Winters) will be accepted through August 2, 2010.

County Committees play a crucial role in helping county office staff implement the 2008 Farm Bill. FSA COC members make decisions on disaster. conservation. emergency, commodity price support and loan programs and other important agricultural issues. Committees consist of three to five members who are elected by eligible local producers. Members serve three-year terms.

Producers are encouraged nominate eliaible to candidates. To become a eligible nominee, individuals must sign form FSA-669A, available in this issue, at FSA County Offices or online at http:www. fsa.usda.gov. This form allows individuals to nominate themselves or any other person as a candidate. Each form submitted must be:

◆Limited to one nominee ◆Signed and dated by the nominee in Item 4. Nominee must sign if willing to have his/her name placed on the ballot and agrees to serve if elected

•Delivered to the County FSA Office or postmarked no later than August 2<sup>nd</sup>

Persons nominated should actively participate in the operation of a farm or ranch and be well qualified for committee work. A producer is eligible if s/he resides in the LAA in which the election is to be held and is eligible to vote. The duties of FSA COC members include:

 Administering farm program activities conducted by the County FSA Office; ♦Informing farmers of the purpose and provisions of FSA programs ♦Keeping the State FSA Committee informed of LAA conditions Monitoring changes in farm programs ♦Participating in county meetings as necessary ♦Performing other duties as assigned by the State FSA Committee
