Farm Reconstitutions

In Farm Service Agency terms, farms are *constituted* to group all tracts having the same owner and the same operator under one farm serial number. When changes in ownership or operation take place, a farm *reconstitution* is called for. The reconstitution — or recon — is the process of combining or dividing farms or tracts of land based on the farming operation. **Deadline to request** a recon is **August 1, 2006** for same crop year. Contact you local FSA office if you have changes to your operation.
