2009 Elections; With the changes in counties, new voting districts were established. Please see attached a map of the districts. All of Franklin will be holding elections for 2009. In Anderson/Woodford LAA2 and 5 will hold election this year. Both counties are seeking nominations. If you farm in Franklin or in LAA2 and 5 of Woodford/Anderson you are invited to get involved and put in your nomination for 2009 fall election.

The new boundaries are:

Anderson County LAA Boundaries

LAA1: From Mercer County line at Clay Lick Road: follow county line west to Alexandria Road; then across Hwy 513 to Salt River; then follow Salt River to Freeman's Bridge, crossing U.S. 62 to Hwy 44; then to Hammond's Creek. Follow Hammond's Creek east across Southern Railway to old Hwy 127 to intersection of Clifton Road; then north to Franklin County line; then follow Franklin County line to Kentucky River, following Kentucky River south to Clay Lick Road.

LAA2: From Franklin County line at Hammond Road south to intersection of Clifton Road; thence to old Hwy 127, then across Southern Railway to Hammond's Creek. From Hammond's Creek to Hwy 44; thence to Glensboro, following Hwy 44 to Pleasant Hill Church and then to Shelby County line at Wayside. Follow county line NE to Hammond Road.

LAA3: From Washington County line near Fairview and follow county line to Alexandria Road; then across Hwy 513 to Salt River. Follow Salt River to Freeman's Bridge, crossing U.S. 62 to Hwy 44; thence to Glensboro, following Hwy 44 to Pleasant Hill Church and then to Shelby County line at Wayside and then south to Fairview.

Woodford County LAA Boundaries

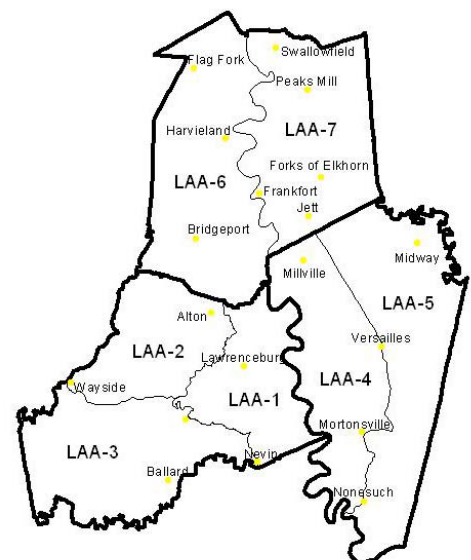
LAA 4: West of line beginning at Franklin County following US 60 through the City of Versailles. From there take Hwy 33 south to Delaney Ferry Road then west to Mortonville, KY. Proceed south on Sellers Mill Road to Fords Mill Road. Follow Fords Mill Road south to Cummins Ferry Road then follow Cummins Ferry Road then follow Cummins Ferry Road west to the river.

LAA 5: Producers east of the above described line will be in LAA 5.

Franklin County LAA Boundaries

LAA6: All land West of the Kentucky River. This includes Bridgeport and Bald Knob.

LAA-7: All land East of the Kentucky River. This includes the communities of Peaks Mill Forks of Elkhorn, and Jett.
