A DCP Direct, Counter-Cyclical, ACRE Direct, and ACRE Payments for 2009 Through 2013 and CTAP Payments for 2014 and 2015

DCP and ACRE payment processing for crop years 2009 through 2013, and CTAP payment processing for 2014 and 2015 has been disabled.

If an overpayment has occurred for a 2009 through 2013 DCP, or ACRE payment, or a 2014 or 2015 CTAP payment, then enter the overpayment according to 64-FI.

To receive authorization to issue a 2009 through 2013 DCP or ACRE payment, or a 2014 or 2015 CTAP payment, State Offices must submit a request through the SharePoint web site according to subparagraph B. The SharePoint web site will allow users to:

- submit documentation for the original request
- submit additional documentation, when applicable
- track the status of the request
- obtain a copy of the authorization or denial
- notify the applicable National Office program specialist of the submitted request.

D Documentation for Payment Authorization Requests

The following documentation will be required for 2009 through 2013 DCP and ACRE payments, and 2014 and 2015 CTAP payments that are due the producer, but were not issued before payment processing was disabled March 31, 2017.

The SharePoint web site must be updated with the following:

- an explanation of why the DCP, ACRE, or CTAP payment was not issued before payment processing was shut down on March 31, 2017
- CCC-509 or CCC-957, as applicable
- Estimated Calculated Payment Report
- Payment History Report Detail for:
 - the producer (access the report by producer name)
 - all members (access the report by member name)
 - combined producers
- subsidiary print for the:
 - producer
 - members, if applicable
- Payment Limitation Detail Report for the:
 - producer
 - members, if applicable
- Farm Payment Reduction Report
- other documentation about the request, such as a NAD decision, FSA-321's, or receivable report, if applicable.--*

E State Office Responsibility

State Office will:

- review the payment authorization request before updating it to the SharePoint site to ensure that the:
 - amount being requested has been earned by the producer
 - request contains all required documentation as provided in subparagraph D before submitting the request
- update the payment authorization request to the SharePoint web site provided in subparagraph B
- be aware that the authorization or denial will be:
 - e-mailed to the SED and requesting State Office specialist
 - available through the SharePoint site
- ensure that State Office specialist personnel changes are provided to the National Office according to subparagraph C.

F County Office Responsibility

County Offices will:

- follow the instructions in this paragraph for payment authorizations and overpayments
- submit payment authorization requests to the State Office with all documentation provided in subparagraph D.--*
