ACREAGE REPORTING

We are now accepting 2008 acreage reports. As soon as your spring crops are planted you need to come into the office and file your crop report. Please remember that failure to file an accurate acreage report for all crops and land uses including failed acreage and prevented planting acreage as well as rangeland and pastureland - can prevent you from qualifying to receive benefits for a variety of programs.

The planting date for all reported crops is also required as part of the acreage report. Acreage reports need to be completed and certified by **June 30, 2008**. **Acreage reports filed after the deadline will be required to pay a \$46 late filing fee**.

Please call before you come so we can review your paperwork prior to your arrival to better serve you. This way we can determine if we need you to bring documentation with you such as BLM, State or Forest Service permits, leases, etc.



If you are participating in <u>ANY</u> of our programs, you MUST file a 2008 Acreage Report before June 30^{th,} 2008.

LIVESTOCK COMPENSATION PROGRAM (LCP)

Livestock producers in Millard County who suffered forage losses due to drought in 2007 may be eligible for benefits under this program.

To be eligible for LCP,

- County must have been designated as a disaster county
- Producers must have owned the livestock on the beginning date of the applicable disaster period, which is January 1st of the 2007
- Livestock must have been located in an eligible county on January 1st of the 2007
- Livestock must have been maintained for commercial use as part of a farming operation
- Producers must have suffered an eligible feed loss from grazed, produced, or purchased forage.

Eligible livestock include beef cattle, equine, elk, sheep and goats. To be eligible, livestock must have been located in an eligible county on January 1 of the applicable year and must have been maintained for commercial use as part of a farming operation.

Please provide our office with the following information when you come in to apply:

- Animal numbers on January 1, 2007.
- Producers who run on BLM, Forest Service or State Lands must bring in their billing statements for 2007 so that we can determine how many AUM's you paid for during the grazing season.

Note: Animal numbers need to be very accurate. If you are selected for spot check and are currently running fewer animals than certified, you will be required to provide sales documentation/or other documentation showing what happened to the animals.

PAYMENT LIMITATION AND ELIGIBILITY

USDA payments and benefits are subject to producer eligibility and limitation provisions as defined by law. Once completed, documents and forms to determine eligibility are reviewed on an annual basis. It is the producer's responsibility to report changes in the farming operation that may affect payment eligibility and payment limitation. Unreported changes could result in the loss of program payments.

Entities such as corporations, limited partnerships, trusts and estates are required to provide names, addresses and identification numbers of their members. These entities should also inform every member of the requirements for designating permitted entities.

A spouse may be considered a "separate person" for payment limitation purposes if the determination is requested and determined eligible.

NON INSURED ASSISTANCE PROGRAM

We would like to remind all participants in the NAP Program that Notice of Loss must be filed timely. You must file a Notice of Loss in writing on From CCC-576 within 15 days of when the loss occurred or when it became apparent to you.

Please remember that NAP coverage is based on intended use of the crop. If you report a crop with an intended use of forage or seed and you decided to change the use of the crop, including destruction of the crop without harvest or grazing, you must notify our office and request that the crop be appraised. Failure to do so may result in a loss of payment or a reduced payment. If your production will be fed or disposed of without a verifiable record, it would be a good idea to request an appraisal so your production can be documented in an acceptable manner. Failure to provide adequate documentation of production may reduce your actual production history (APH) yield in a future year. Production information is due by the final reporting date of the succeeding year in which the crop was produced. In most cases for Millard County, this would be June 30th.

LOW INTEREST LOANS AVALIABLE FROM **FSA**

FSA may be able to assist your farming operation with an operating or ownership loan. The rate for operating loans approved in April 2008 is 3.25% and Farm Ownership is 4.875%. It is the time of year where farmers begin thinking of our spring planting needs. Whether you need loan funds to finance your spring needs for fertilizer, seed, or you need to upgrade your equipment line with a new tractor, planter, baler, or perhaps you have been thinking about expanding your operation or need credit to increase your production, FSA may be able to help.

FSA's loan programs are designed to help family farmers who are temporarily unable to obtain private or commercial credit. FSA also provides credit to beginning farmers, most do not have sufficient net worth to qualify for commercial credit. In other cases, they are farmers who have suffered financial setbacks from natural and economic disasters, or who have limited resources with which to establish and maintain profitable farming operations.

HIGHLY ERODIBLE LAND AND WETLAND CONSERVATION COMPLIANCE

All participants in USDA programs are required to have a conservation system in place on all the highly erodible land (HEL) that they operate. Compliance problems can arise in the following situations:

- Proper amounts of crop residue are not left on the soil surface as required by the conservation plan.
- Highly erodible land is plowed more often than allowed in the conservation plan.
- New land is broken out without a revised conservation plan.
- Producers begin planting crops not addressed in their conservation plans.

It is also important that you contact our office before draining, dredging or filling any wetland.

Failure to follow Highly Erodible Land and Wetland Conservation Provisions can result in the loss of program payments.

WOOL LDP'S

The wool loan deficiency payment program provides payments to producers for Wool produced and shorn from live sheep. All producers who will sell their wool in 2008, need to have form CCC-633EZ on file in our office. This form needs to be on file before wool is sold. Producers who received a wool payment in 2007 should have received this form in the mail.

Producers need to bring their receipts to the Farm Service Agency office after wool has been sold. Payments will be made to the person whose name is on the receipt. All sales receipts for wool sold in 2008 must be submitted for payment before January 31, 2009.

CROP DISASTER PROGRAM (CDP)

Farmers who suffered crop losses because of natural disasters may be eligible to receive benefits through the new Crop Disaster Program.

You may be eligible if you suffered losses from natural disasters that occurred in 2005, 2006 or 2007. The Crop Disaster Program has been amended to include all crops planted for the 2007 crop year. This would include all spring planted crops. Producers who filed a 2005 or 2006 Crop Disaster application may want to reevaluate their 2007 losses to make sure maximum benefits are received under this program. Producers must have suffered losses in excess of 35 percent of their expected production to qualify.

Note: Only producers who obtained crop insurance coverage or coverage under the Non Insured Crop Disaster Assistance Program (NAP) for the year of the loss will be eligible for CDP benefits.

Producers who incurred qualifying losses in 2005, 2006 or 2007 must choose only one year for which to receive benefits. They may receive benefits for multiple crop losses if all were in the same crop year.

Eligible damaging conditions would include drought, excessive moisture, hail, excessive wind and freeze.
