INFORMATION / TRAINING FOR NEW FARMERS AND RANCHERS

County Agricultural Commissioner (in your county) – check in with your own local county government's Ag experts whose mission is to advise and assist growers in their counties. University of California – Cooperative Extension Service – working closely with the county ag commissioners, the "Ag Extension Agents" have local offices and staff around the state to advise regional growers, big and small. California FarmLink – a respected non-profit organization with a history of success helping new farmers through conferences, networking, financial training, marketing advice and other resources. Agriculture and Land-Based Training Association (ALBA) - provides education, business opportunities and assistance for farm workers and aspiring farmers to grow and sell crops. Program services include the 195-hour Farmer Education Program (PEPA), monthly farmer workshops and field days, and farmer technical assistance. The Center for Land-Based Learning - operates an innovative agricultural training program in Northern California called the **California Farm Academy**. This hands-on learning experience takes place on a part-time basis, with classes held on evenings and weekends – serving people with busy schedules. Conducted as a real-world learning program as well as a farm business incubator for start-up agricultural operations, the Academy staff teaches and mentors new farmers in agricultural production, business planning and marketing of specialty crops and livestock. www.californiafarmacademy.org

California Small Farm Conference – a major yearly conference supported by most of the agencies, organizations and educational institutions listed above. This annual multi-day conference with tours and commercial exhibits provides a wealth of ideas, information and valuable "network" contacts for smaller operators and start-up agricultural ventures. USDA – Agricultural Marketing Service (AMS) - in addition to research and promotion of U.S. agricultural commodities, AMS manages and promotes U.S. organic agriculture and assists the development of farmer's markets and improved transportation. Focusing on small to medium sized farms, AMS provides several information and grant programs to assist in selling through farmer's markets and selling to federal procurement programs. <u>www.ams.usda.gov</u> and search for "Farmers Markets and Local Food Marketing."

Certified Farmers Market Program CFM's provide a great opportunity for small farmers to market their products without the added expenses of commercial preparation. This CDFA-coordinated system of scheduled retail markets increases their net income and makes it possible for them to stay in business. Farmer Veteran Coalition – focusing on returning men and women veterans, this organization holds educational and informational events, provides training and internship experiences and counsels aspiring farmers on how to succeed in the field of agriculture. Focus also includes vocational training on other agricultural occupations in addition to farm ownership. LOANS / GRANTS FOR NEW FARMERS AND RANCHERS

USDA Farm Service Agency - Farm Operating Loans and Farm Ownership Loans - Ioan funds are reserved for Beginning and for Socially Disadvantaged Farmers and Ranchers in this credit program. Lending by FSA is for those unable to obtain credit elsewhere. ORGANIC FARMING AND RANCHING

CA Organic Program - California Department of Food and Ag. (CDFA) - CDFA's Organic Program is responsible for enforcement of the federal Organic Foods Production Act of 1990, and the California Organic Products Act of 2003. These statutes protect consumers, producers, handlers, processors and retailers by establishment of standards under which fresh agricultural products/foods may be labeled and/or sold as "organic". The California Department of Public Health enforces laws pertaining to processed products marketed as "organic". www.cdfa.ca.gov/is/i & c/organic.html
