The extension is due to issues involving the performance of the Farm Service Agency's web- based computer system. The late-file fee of \$100 will only be assessed for farms that are enrolled after August 3, 2007 and before September 28, 2007. August 3rd is also the final day to return all signatures to the DCP contract without being assessed a late fee. Acreage Reporting

Farm Storage Facility Loans

Low cost loans for storage facilities are available for producers to build or remodel farm storage facilities for commodities. The seven-year Farm Storage Facility Loans are available for the purchase and installation of eligible storage facilities, permanently affixed drying or handling equipment, or remodeling existing facilities. Eligible facilities include new conventional-type cribs or bins and new and remanufactured oxygen-limiting and other upright silo-type structures.

All Farm Storage Facility Loans are secured by a promissory note and security agreement. The maximum amount that may be borrowed is 85 percent of the net cost of the storage or handling equipment, up to \$100,000 for each borrower. A minimum down payment is also required. For details, contact the county office staff.

MAINTENANCE OF CONSERVATION RESERVE PROGRAM (CRP) COVER

Participants in the Conservation Reserve Program (CRP) are reminded that they are responsible for maintaining the cover of all CRP acreage in accordance with their Conservation Plan of Operations (CPO). Weeds and noxious weeds must not be allowed to produce seed. Brush and trees must be controlled on the CRP. The CRP acres can't be used to store machinery, vehicles, bales, etc. Unauthorized haying or grazing is not permitted. Penalties for these violations include a refund of all previous rental payments, cost shares, incentive payments, interest, and liquidated damages. Corrective action must not be taken during primary nesting season which began April 15 and continues through July 15.

OÉELECTION

The election for a County Committee (COC) member this year will be for Local Administrative Area (LAA) #3. LAA #3 is in the southern part of Butler County which includes the following townships: Bruno, Augusta, Spring, Little Walnut, Glencoe, Pleasant, Walnut, Bloomington, Logan, Hickory, Richland, Douglas, Rock Creek, Clay, and Union. Nomination forms for this position will be accepted until August 1st, 2007. The nominee must meet certain requirements such as be willing to serve, eligible to vote, and reside in LAA #3. Ballots will be mailed to eligible voters on November 2, 2007.

CP33 Acres Available

Kansas received an additional allocation of 35,000 acres for Habitat Buffers for Northern Bobwhite Quail under the Conservation Reserve Program practice CP33. Kansas currently has over 27,500 habitat buffers enrolled.

The purpose of CP33 is to provide food and cover for bobwhite quail in cropland acres. Cropland must be suitably located and adaptable to the establishment of bobwhite quail. Buffer species may include native warm-season grass, legumes, wildflowers, forbs, and limited shrub plantings, as specified in the participant's approved conservation plan. This practice qualifies for incentive payments.

Eligible land may be enrolled in CP33 anytime under the continuous CRP. However, signup for the practice will end December 31, 2007 or when the allocated acres are enrolled, whichever comes first. When the entire allocation is enrolled, Kansas will have 62,500 acres in habitat buffers.

Act of 2007

On May 25, 2007, President Bush signed into law the "U.S.Troop Readiness, Veterans' Care, Katrina Recovery, and Iraq Accountability Appropriations Act, 2007" (2007 Act). The 2007 Act provides approximately \$3 billion in agricultural disaster aid for America's farmers and ranchers.

Specifically, the 2007 Act provides funds for a Crop Disaster Program (**CDP**), Livestock Compensation Program (**LCP**), Livestock Indemnity Program (**LIP**), Emergency Conservation Program (**ECP**) and Dairy Disaster Assistance Program (**DDAP**). The 2007 Act also extends the Emergency Forestry Conservation Reserve Program (**EFCRP**). Additionally, the 2007 Act extends the Milk Income Loss Contract (**MILC**) program through September 2007.

Crop Disaster Program (CDP)

CDP provides benefits to farmers who suffered quantity and quality losses from natural disasters and related conditions that occurred in 2005 and 2006 and for 2007 crops if the crop was planted before Feb. 28, 2007, or in the case of prevented plantings would have been planted before Feb. 28, 2007. Producers who incurred qualifying losses in 2005, 2006 or 2007 must choose only one year to receive benefits. Producers may apply for benefits for losses to multiple crops as long as the losses occurred in the same crop year.

Producers must have suffered quantity losses in excess of 35 percent to be eligible for CDP.

Only producers who obtained crop insurance coverage or coverage under the Noninsured Crop Disaster Assistance Program (NAP) for the year of loss will be eligible for CDP benefits.

USDA will announce and conduct sign-up for CDP as soon as possible.

FOREIGN INVESTORS 90-DAY REPORTING RULE

Foreign owners of U.S. agricultural land are required by law to report their land holdings, acquisitions, leases of 10 years or more, and land use changes within 90 days to the local FSA office. Failure to report these changes can result in a civil penalty of up to 25% of the fair market value of their interest in the agricultural land.
