## **Featured Item**

### **Emergency Conservation Program Authorized for Rim Fire Damage**

The Stanislaus-Tuolumne Farm Service Agency (FSA) County Committee recently requested and was granted authorization to administer the Emergency Conservation Program (ECP) as a result of the significant damage caused by the Rim Fire in Tuolumne County. ECP provides emergency funding and technical assistance to farmers and ranchers to rehabilitate farmland and rangeland damaged by natural (and other causes addressed via waiver) disasters. ECP participants may receive cost-share assistance of up to 75% of the cost to implement approved emergency conservation practices. Emergency conservation practices included in this authorization are:

- EC1- Removing Debris from Farmland
- EC3- Restoring Permanent Fences (reduction in cost share percentage applied for age)
- EC4- Restoring Conservation Structures and Other Installations (such as permanently installed irrigation systems, etc)

Individual requests for cost-share assistance of \$50,000 or less per person or legal entity, per disaster are approved at the County Committee level. Cost-share assistance requests exceeding \$50,000 require approval from the State Committee or National Office level. Cost-share assistance is limited to \$200,000 per person or legal entity, per disaster. Funding for ECP is appropriated by Congress. Please contact the Stanislaus-Tuolumne County FSA Office at (209) 491-9320 ext 2 if the Rim Fire (that began August 17, 2013 and was contained October 24, 2013) caused significant damage to your farm/ranch or if you have any questions regarding ECP. **Applications for ECP are being accepted through February 7, 2014**.

## Farm Service Agency County Committee Election Rescheduled

Due to a problem with the initial election ballot, FSA provided a new election ballot to all eligible voters in the 2013 voting areas in mid-December. The final date to cast a ballot (postmarked) in the FSA County Committee election is **January 17, 2014**.

## **USDA Debuts One-Stop Shop for Organics**

The "one-stop shop" contains helpful information on all of USDA's programs, services and data that supports organic agriculture. Visitors can learn about improved organic crop and livestock insurance, view local and national organic commodity price reports and other economic data, identify additional export markets for their products, and much more.

#### **Almond Grower Referendum**

Every five years, eligible almond growers in California are provided an opportunity to vote on whether to continue their federal marketing order program, administered by the Almond Board of California with oversight by the USDA. The next almond grower referendum will be conducted in **February 2014**. To vote in this referendum, growers must have produced California almonds during the period of August 1, 2012 through July 31, 2013. Growers will receive their ballots directly from USDA/AMS Fresno, CA office during the month of February 2014. To allow the program to remain in effect, at least two-thirds of the growers voting in the referendum, or growers representing at least two-thirds of the volume of almonds represented in the referendum would have to vote in favor of the order.

## **Grape Crush Preliminary Report Scheduled for February 10** *Workbooks due January 10*

The 2013 Grape Crush survey of grapes crushed and/or purchased is nearing the end of the data collection stage. Completed workbooks must be submitted by January 10, 2014. The electronic workbook can be found at <a href="http://www.nass.usda.gov/ca">http://www.nass.usda.gov/ca</a>. A Preliminary Report will be published **February 10, 2014** and a Final Report will be available March 10, 2014. Information contained in the Report is supplied by processors to fulfill the reporting requirements of Section

55601.5 of the California Food and Agricultural Code. The Grape Crush Report includes all grape tonnage crushed during the 2013 season. Assessment fees, designated for the work of the Pierce's Disease/Glassy Wing Sharp Shooter Program, are collected in conjunction with the annual Grape Crush survey. ## NASS Continues to Visit Farms for CEAP Survey Through February

Under a cooperative agreement with Natural Resources Conservation Service (NRCS), the National Agricultural Statistics Service (NASS) is conducting the 2013 National Resources Inventory Conservation Effects Assessment Project (NRI-CEAP) survey of farming and conservation practices. The 2013 NRI-CEAP takes place in the California Bay Delta watershed area with a primary focus on the Sacramento River Watershed, the San Joaquin River Watershed, and the Tulare Lake Basin Watershed. NASS representatives are visiting approximately 1,732 farms in California and 32 farms in Oregon **through February 2014** to collect information about on-farm conservation practices. #### **Census of Agriculture Results Coming Soon**

Be on the lookout – NASS will release preliminary 2012 Census of Agriculture results on **February 20**. The results will be presented at the USDA Agricultural Outlook Forum and be available online at <a href="http://www.agcensus.usda.gov">http://www.agcensus.usda.gov</a>. The Census of Agriculture provides the most consistent and comprehensive information about conditions and trends in U.S. agriculture. NASS finished collecting Census data late last summer. The full 2012 Census publication is certain to show interesting trends over the past five years and will contain several pieces of data that were collected for the first-time ever. Among the new information are statistics about biomass, Internet access, regional food marketing and distribution, land use practices, and agroforestry. The data are critically important in telling the story of American agriculture for the 98% of Americans who don't live on the farm and the more than 80% who do not live in rural areas. NASS will announce a release date for the full report as soon as it is set. NASS delayed publication of the full 2012 Census of Agriculture as a result of the work stoppage caused by the lapse in federal funding in October 2013.

## **Application Closing Date Nears for Non-Insured Crop Disaster Assistance Program**

2014 Non-Insured Crop Disaster Assistance Program (NAP) application closing dates for several crops are fast approaching. Please make sure to file an application for coverage and pay the service fee for your crop policy before these dates have passed. **January 31, 2014** is the last day to buy coverage for apples and **March 1, 2014** is the last day to buy coverage for annual crops (tomatoes, peppers, carrots, etc.). ### Sales Closing Date Nears for Crop Insurance Programs

Sales closing dates for several crop insurance programs are almost here. Please make sure to sign up, review, or change your crop policy before these dates have passed. **January 31, 2014** is the last day to buy or change your policy for AGR, Apples, Cherries, Fresh Market and Processing Tomatoes, Grapes and Table Grapes, Olives, Potatoes (spring planted in San Joaquin County), Stonefruit, and Walnuts. **February 1, 2014** is the last day to buy or change your policy for onions in Modoc and Siskiyou Counties. ## Acreage Reporting Deadline for Farm Service Agency

## **Farm and Ranch Lands Protection Program**

The USDA Natural Resources Conservation Service (NRCS) in California has set **February 14**, **2014**, as the deadline for accepting applications for the Farm and Ranch Lands Protection Program (FRPP). FRPP is a voluntary program that provides matching funds to State, Tribal, or local governments and nongovernmental organizations with existing farmland protection programs to purchase conservation easements. Land trusts and other eligible entities interested in permanently protecting farm or ranchlands in California are encouraged to get their applications in soon. FRPP proposals are to be submitted to the Davis, California, NRCS State Office.

## **Applications Accepted for Value-Added Producer Grants**

Rural Development is accepting applications for the Value-Added Producer Grant (VAPG) program until **February 24, 2014.** Maximum awards are \$75,000 for planning grants and \$200,000 for working capital grants.
