Free Farm Bill Update Webinars

All four webinars will begin at 5:30 p.m. and will last about one hour. Participants will hear from experienced speakers and have opportunities to ask questions.

Webinar 1 – Wednesday, March 11: Participants will learn about the 2014 Farm Bill with emphasis on the noninsured crop disaster assistance program (NAP). Alaska Farm Service Agency Farm Loan Specialist Jeff Curry and county executive directors from Alaska will be present to help address questions.

Webinar 2 – Monday, March 30: Participants will learn how to analyze, assess and use their financial data to make more informed management decisions.

Webinar 3 – Tuesday, March 31: Participants will learn what insurance products are available to Alaska farmers and how insurance can be used to help manage risks.

Webinar 4 – Wednesday, April 1: Participants will learn how record keeping is critical to managing income tax liabilities.
