Commodity Loans & Program Payments: \$67,352,952

Pennsylvania producers received substantial monetary support during FY 2012 in the form of commodity and price support program payments.

\$18,925,547 - Direct and Counter Cyclical Program (DCP) Direct payments provide income support to producers of eligible commodities based on production history (acreage and yields) and do not depend on the current production choices. Counter-cyclical payments are made when the effective price for eligible commodities is less than the target price.

\$698,146 - Average Crop Revenue Election Program (ACRE) provides revenue-based payments as an alternative to receiving price-based counter-cyclical (CC) payments.

\$33,380,129 - Milk Income Loss Contract (MILC) provides compensation to dairy producers when domestic milk prices fall below a specified level.

\$12,203,202 - Price Support - provides financial assistance to producers when the commodity prices are low. This includes price support loans, LDPs, and market loss assistance payments.



\$36,000 - Trade Adjustment Assistance (TAA) provides technical assistance and cash payments to producers of products that were adversely affected by imports.

\$2,109,928- Farm Storage Facility Loans (FSFL)The Commodity Credit Corporation (CCC), through FSA, may make loans to producers to build or upgrade farm storage and handling facilities for eligible commodities.

Conservation: \$26,077,729

FSA made significant investments toward conserving and improving soil, water, and wildlife resources in Pennsylvania. Conservation investments in FY 2012 include:

\$24,931,418- Conservation Reserve Program (CRP) provides financial incentives, cost-share and rental payments to producers who convert highly erodible cropland or environmentally sensitive acreage

to long-term vegetative cover.

\$628,469 - Emergency Conservation Program (ECP) provides emergency funding for farmers and ranchers to rehabilitate farmland damaged by natural disasters and carry out emergency water conservation measures during periods of severe drought.

\$148,710 - Grassland Reserve Program (GRP) is a voluntary program designed to protect grasslands from conversion to cropland or other uses and conserve valuable grasslands by maintaining viable ranching operations.

\$369,132 - Biomass Crop Assistance Program (BCAP) - assists land owners and operators with the collection, harvest, storage and transportation of eligible material used in a biomass conversion facility.

Disaster Assistance: \$1,945,895

From drought to flood, freeze and tornadoes - FSA was financially responsive to Pennsylvania producers following natural disasters.

\$688,618 - Non-Insured Crop Disaster Assistance Program (NAP) provides financial assistance to producers of noninsurable crops when low yields, loss of inventory, or prevented planting occurs due to natural disasters.

\$593,491 - Supplemental Revenue Assistance Payment (SURE) provides benefits for 2008 through 2011 crop year farm revenue losses due to natural disasters. It is the 2008 Farm Bill's successor to prior ad hoc crop disaster programs.

\$342,572 - Livestock Indemnity Program (LIP) provides partial reimbursements to eligible livestock owners for livestock losses suffered due to a natural disaster or other emergency.

\$321,214 - Emergency Livestock Assistance
Program (ELAP) provides emergency assistance to
eligible producers that have livestock losses due to
disease, adverse weather or other conditions, including
losses due to flooding and blizzards.



Farm Loans: \$63,326,000

FSA offers various loan options to Pennsylvania farmers and ranchers who manage family-sized operations and who were temporarily unable to obtain private or commercial credit.

\$23,654,000 - Guaranteed Loan Program FSA guarantees loans made by conventional agricultural lenders for up to 95 percent of any loss if the loan fails. In FY 2012, FSA guaranteed **44** farm ownership loans and **81** operating loans.

\$1,751,000 - Emergency Loan Program helps producers who own or operate a farm in a declared disaster area.

\$37,922,000 - Direct Loan Program FSA provides assistance to those unable to obtain guaranteed loans. In FY 2012, FSA funded **44** farm ownership loans and **464** operating loans.

Included in the direct and guaranteed direct loans are youth loans, loans to beginning farmers and loans to socially disadvantaged producers.
