2007 DISASTER PROGRAMS EXTENDED TO INCLUDE ALL 2007 CROPS AND LOSSES

On December 26, 2007, the President signed into law the Department of State, Foreign Operations and Related Programs Appropriations Act, 2008 (The 2008 Act). This act included provisions to extend the eligibility date for crops planted and harvested to December 31, 2007. All other eligibility requirements were not changed. This includes the requirement that you must have purchased either crop insurance or NAP and have a qualifying loss (more than 35%) due to a natural disaster that occurred between January 1, 2005 and December 31, 2007.

For CDP purposes, this date change does not make 2008 crops planted in 2007 eligible under CDP.



Signup for CDP is underway. *Please contact* your local county office to schedule an appointment to make application.

NAP/CROP INSURANCE DEADLINES

This is a reminder, the deadline to purchase crop insurance and NAP is March 15th for crops that are annually planted in the spring. Crop insurance is available from an insurance agent and NAP is available from our office. NAP is available for any crop that is not covered by crop insurance. The cost is \$100 a crop, with a maximum payment of \$300 per county. If you have any questions please contact our office.

DDAP-III

A new program called Dairy Disaster Assistance Payment III (DDAP-III) Program has been approved. To qualify producers must have had a loss in production from the dairy operations base years (2003-2004) in 2005, 2006 or 2007 due to a declared natural disaster. Producers must provide our office with the average number of cows in the herd (this includes the dry cows) for the base years and the years for which you are applying. We will also need your total production for those years. A statement authorizing your milk handler (cooperative) to send this information directly to our office, is available.

BEWARE OF CROP INSURANCE REBATING SCHEMES

With the spring sales closing date for many Federal crop insurance policies right around the corner, crop insurance agents have stepped up their marketing efforts. The Risk Management Agency (RMA) has received reports from producers and agents that some aggressive marketers have been approaching producers with rebating offers. These schemes promise lower insurance premiums, refunds, dividends, or items of value tied to crop insurance purchases. Most of these activities are illegal. RMA reminds all Federal crop insurance program participants that it is now coordinating with state regulators to take appropriate regulatory action against all those who are found to promote or participate in such schemes. **Producers who are found to participate in illegal rebating activities will not only lose their crop insurance coverage but will also lose eligibility in all USDA programs**. 2005-2007 LIVESTOCK COMPENSATION PROGRAM (LCP)

LCP provides benefits to livestock producers who suffered feed losses or incurred additional feed costs directly resulting from natural disasters occurring between January 1, 2005, and December 31, 2007.

Producers in primary or contiguous counties declared secretarial disaster areas or counties declared presidential disaster areas between January 1, 2005, and December 31, 2007, are eligible. Also, producers in primary counties (and contiguous counties) that received an approved Administrator's Physical Loss Notification (APLN), when the APLN is directly associated to a natural disaster designated by President Bush, are eligible.

To be eligible under LCP, livestock must be dairy cattle, beef cattle, buffalo, beefalo, equine, poultry, elk, reindeer, sheep, swine, goats or deer that:

- ▶ have been physically located in an eligible county on the beginning date of the applicable disaster period;
- > have been maintained for commercial use as part of a farming operation on the beginning date of the disaster period; and
- have not been produced and maintained for reasons other than commercial use as part of a farming operation. Such excluded uses include, but are not limited to, wild free roaming animals or animals used for recreational purposes such as pleasure, hunting, pets, roping or for show.

Eligible producers must have either owned or cash-leased eligible livestock (but not both for the same livestock) on the beginning date of the applicable disaster period and must be a citizen of, or legal resident alien in, the United States. They also must have suffered an eligible feed loss from produced or purchased forage or feedstuffs, or incurred additional feed costs as a result of eligible disaster events during the applicable disaster periods. The feed lost or additional incurred feed costs must have been intended for use with eligible livestock.

FSA will calculate LCP payments by multiplying the national payment rate for each livestock category by the number of eligible livestock in each category. Producers may receive no more than \$80,000 under LCP. An individual or entity whose average adjusted gross income exceeds \$2.5 million for the three years immediately preceding the calendar year for which benefits are requested is ineligible for LCP benefits unless 75% or more of their income is from agriculture.



In addition to a completed application filed during the application period, livestock producers applying for LCP must submit adequate proof that the feed loss or incurred additional feed costs:

- were for the claimed eligible livestock;
- occurred as a direct result of an eligible disaster event during an eligible disaster period in the calendar year for which benefits are being requested;
- other supporting documentation necessary to determine the applicant's eligibility. Supporting documents may include, but are not limited to, verifiable purchase records, veterinarian records, bank of other loan papers, rendering truck receipts, FEMA records, National Guard records, written contracts, production records, IRS records, property tax records, private insurance documents, sales records or similar documents.

Signup for the 2005-2007 Livestock Compensation Program began September 10, 2007. No final signup date has been announced. *Please contact your local county office to schedule an appointment to make application.*

EMERGENCY FARM LOANS AVAILABLE

USDA's Farm Service Agency (FSA) provides emergency loans to help producers recover from production and physical losses due to drought, flooding, other natural disasters, or quarantine.

Emergency loans may be made to farmers and ranchers who:

- Own or operate land located in a county declared by the President as a disaster area or designated by the Secretary of Agriculture as a disaster area or quarantine area (for physical losses only, the FSA Administrator may authorize emergency loan assistance);
- Are established family farm operators and have sufficient farming or ranching experience;
- Are citizens or permanent residents of the United States;
- Have suffered at least a 30-percent loss in crop production or a physical loss to livestock, livestock products, real estate, or chattel property;
- Have an acceptable credit history;
- Are unable to receive credit from commercial sources;
- Can provide collateral to secure the loan; and
- Have repayment ability.

The current annual interest rate for emergency loans is 3.75 percent.

2007-CROP COMMODITY LOANS AVAILABLE

Marketing assistance loans provide producers interim financing at harvest time to meet cash flow needs without having to sell their commodities when market prices are typically at harvest-time lows. Loans mature on the last day of the ninth calendar month following the month in which the loan is approved. Contact your local office for more information.

FOREIGN LANDOWNERS REPORTING REQUIREMENT



The Agricultural Foreign Investment Disclosure Act (AFIDA) requires all foreign owners of U.S. agricultural land to report their holdings to the Secretary of Agriculture. The Farm Service Agency administers this program for USDA. Foreign persons who have purchased or sold agricultural land in the county are required to report the transaction to FSA within 90 days of the closing. Failure to submit the AFIDA form could result in civil penalties of up to 25% of the fair market value of the property. County government offices, realtors, attorneys and others involved in real estate transactions are reminded to notify foreign investors of these reporting requirements.

2008 CROP YEAR WOOL LDP

The deadline to request a 2008 crop year Wool LDP is March 15, 2008. If you have a wool receipt for 2008 and have not turned it in yet, please do so by the deadline.

eGOV CUSTOMER REGISTRATION PROCESS

- 1. Access your website of interest:
 - USDA Customer Statement http://customerstatement.usda.gov
 - Electronic LDP Signup http://www.fsa.usda.gov/egov/eldp default.htm
 - Electronic DCP Signup http://www.fsa.usda.gov/egov/edcp default.htm
- 2. Create an online user profile and apply for Level 2 access
- 3. Respond to the verification email within 7 days of receipt.
- 4. Visit the County Office in person and provide photo identification to the Local Registration Authority in order to receive Level 2 Activation.
- 5. Access Level 2 applications within 1 hour after profile has been activated.
