Final 2006 DCP Payments

If you're watching the mailbox for your final direct payment from the 2005 Direct and Counter-cyclical Program, you're jumping the gun. The final direct payment will be issued the end of September or first of October.

Producers who did not elect to receive an advance direct payment (which are distributed in December) will receive the entire direct payment in October.

The direct payment for a crop equals 85 percent of the farm's base acreage *times* the farm's direct payment yield *times* the direct payment rate.
