

**ANNOUNCEMENT KCRSRP1, INVITATION NO. 3  
EXCHANGE OF COMMODITY CREDIT CORPORATION-OWNED SUGAR  
FOR LICENSE CREDITS UNDER THE REFINED SUGAR RE-EXPORT PROGRAM**

The Commodity Credit Corporation (CCC) invites offers, subject to the terms and conditions of this Announcement and Invitation, from licensed refiners to exchange license credits under RSRP (7 CFR Part 1530) for approximately 77,451 metric tons of CCC-owned sugar. For the purpose of this invitation, the metric ton conversion is 2,204.62262 pounds. Validation and recognition of each U.S. refiner's re-export license and license credits will be at the sole discretion of CCC.

Quality of exchanged raw cane sugar will be based on KC-227, Raw Sugar Certification Report, and quality of exchanged refined beet sugar will be based on KC-227-A, Refined Sugar Certification Report. Offerors (holders of the RSRP credits) are encouraged to contact Warehouse Operators (Sugar Processors) in advance of bidding to discuss the quality of sugar to be delivered, a delivery schedule, and to prearrange a schedule for premiums and discounts. CCC will not be responsible for the quantity or quality of sugar delivered out of the storage facility, nor will CCC be responsible for any storage or handling charges, including loadout.

CCC Sugar Storage Agreement (SSA) rates are \$0.08 per cwt per month for raw cane sugar and \$0.10 per cwt per month for refined beet sugar. Offerors will be responsible for storage charges starting September 1, 2013. The rate for load out is \$0.18 per cwt for all sugar types.

Selection criteria will be based on the best value to CCC. Offers may be submitted with an exchange ratio up to five decimal places.

A catalog listing with CCC-owned quantities is attached to this Announcement/Invitation. Participants are encouraged to make offers on all catalog items. CCC will only award up to the maximum credits each participant is willing to exchange for CCC-owned sugar. No offer on any one catalog item number will be contingent upon the acceptance of another catalog item number.

The licensed refiner agrees that any exchange resulting in a positive balance on their RSRP account shall be deemed an entry of raw cane sugar for the purposes of the provisions of 7 CFR Section 1530.105(a). If the RSRP license lacks sufficient capacity for the volume of sugar covered by that bid, CCC reserves the right to reduce the quantity of sugar awarded, in order to keep the license balance within program limits. CCC reserves the right to accept or reject any or all offers, or portions thereof.

Offers and any modifications or withdrawal of offers must be received in the Kansas City Commodity Office (KCCO) by 1:30 p.m., CT, September 17, 2013.

Successful Offerors will be notified of acceptance by telephone not later than 1:30 p.m., CT, September 18, 2013, followed by written confirmation. Title of sugar intended for exchange will transfer to the RSRP license holder upon contract award. Following this action, the Foreign Agricultural Service (FAS) will notify successful bidders of the RSRP adjusted license credit balance.

The envelope containing offers must be plainly marked “DO NOT OPEN UNTIL PRESCRIBED TIME UNDER ANNOUNCEMENT KCRSRP1, INVITATION NO. 3.” Offerors are responsible for the timely receipt of offers and any modifications, or withdrawal of offers.

## **SUBMISSION OF OFFERS**

### **A. How to Submit Offers**

- (1) Offers, modifications, withdrawals, and cancellations shall be submitted by one of the following methods. Submission via fax is at the Offeror’s risk.
  - (a) Express or regular mail, and/or hand delivered. Place clearly the notation “Offer under Announcement Invitation KCRSRP1” on the envelope.
  - (b) Facsimile (FAX) to (816) 926-6795. Place in the subject line “Offer under Announcement Invitation KCRSRP1”.
- (2) Offer forms must be signed. Reproductions of the offer form are acceptable.
- (3) CCC will not be responsible for any failure attributed to the transmission or receipt of faxes including, but not limited to, the following:
  - (a) Receipts garbled or incomplete;
  - (b) Availability or condition of the receiving fax equipment;
  - (c) Incompatibility between the sending and receiving equipment;
  - (d) Failure of the Offeror to properly identify the information;
  - (e) Illegibility of the information; and
  - (f) Security of data.

- (4) Envelopes containing the offers are to be sealed and marked with the name and address of the offeror in the upper left corner. Offers submitted by express mail must be sealed inside a second envelope. All envelopes must be plainly marked with the following statement, **“DO NOT OPEN UNTIL PRESCRIBED TIME UNDER ANNOUNCEMENT KCRSRP1, INVITATION (Enter Appropriate Invitation Number).”** If overnight/express service is utilized, this statement must be printed clearly on the outer express envelope, not on the mailing label.
- (5) Changes by facsimile must contain the required signatures.

**B. Where to Submit Offers**

- (1) Offers, modifications, withdrawals, and cancellations of offers shall be submitted to KCCO and must be received by the date and local time specified in the invitation for receipt of offers.

- (2) If an offer is sent by fax, the recorded date and time per incoming facsimile will serve as proof of receipt for CCC. OFFERORS ARE RESPONSIBLE FOR THE TIMELY RECEIPT OF OFFERS AND AMENDMENTS. No offers, modifications, or withdrawals will be accepted by telephone.
- (3) If an offer is sent by express or regular mail and/or hand delivered, the date and time of receipt will be recorded by the Kansas City Administrative Office’s date and time stamp.

**C. What to submit**

Each Offeror shall submit a completed CCC-331B, Offer Form (attached) of the Announcement/Invitation. Reproduction of the form is permissible.

D. Basis of Offer

The content of an offer will include:

- (1) Announcement KCRSRP1, Invitation 3;
- (2) Company name, address, RSRP license number, contact name, telephone and facsimile numbers, email address;
- (3) The offeror's maximum quantity of credits to be considered for this Invitation;

**PROVISIONS OF CONTRACT**

The contract will consist of:

- (1) Licensee's offer;
- (2) CCC's Acceptance of Offer; and
- (3) This Announcement/Invitation.

**TRANSFER OF TITLE**

Transfer of title to successful offeror will occur upon contract award.

**LICENSE CREDIT ADJUSTMENT**

If CCC accepts your bid, your license credit will be adjusted accordingly. FAS will notify successful bidders of the RSRP adjusted license credit balance. The licensed refiner agrees that any exchange resulting in a positive balance on its RSRP account shall be deemed an entry of raw cane sugar for the purposes of the provisions of 7 CFR Section 1530.105(a). If the re-export license lacks sufficient capacity for the volume of sugar covered by that bid, CCC reserves the right to reduce the quantity of sugar awarded, in order to keep the license balance within program limits.
