

# **Glacial Habitat Restoration Area SAFE**

Winnebago, Fond du Lac, Dodge and Columbia Counties

#### Wisconsin Farm Service Agency

USDA's Farm Service Agency (FSA) and Natural Resources Conservation Service (NRCS), in partnership with the Wisconsin Department of Natural Resources. is offering a Conservation Reserve Program (CRP) practice tailored to provide enhanced habitat

for bobolinks, eastern meadowlarks, grasshopper sparrow, Henslow's sparrows, and ring-necked pheasant. This practice, established through FSA's State Acres for Wildlife Enhancement (SAFE) initiative, is available to eligible participants in parts of Winnebago, Fond du Lac, Dodge, and Columbia counties.

#### Goals

The goal of this practice is to establish a mosaic of grasslands and wetlands in a predominately agricultural landscape, resulting in more favorable habitat conditions for self-sustaining populations of waterfowl, pheasants, and grassland songbirds.

## **Practice Specifications**

SAFE practices include establishment of shallow water areas for wildlife, wetland restorations, cool season grasses, warm season grasses, tall grass prairies, and oak savanna. Existing grass cover is also included.

These practices will provide a diverse array of grassland and wetland types which will benefit the species targeted by the project.

## Land Eligibility

To be eligible for placement in a SAFE CRP practice, land must be:

Cropland (including field margins) that is planted or considered planted to an agricultural commodity 4 of the previous 6 crop years from

2002 to 2007 (some existing grass may be eligible)

- Physically and legally capable of being planted in a normal manner to an agricultural commodity
- Located within the state designated SAFE area
- A maximum of 2,250 acres in the designated counties are available for this project.

## Participant Eligibility

CRP participants must have:

- Owned or operated the land for the previous 12 months, some exceptions may apply
- An average adjusted gross income of less than \$1 million unless 66% or more of the average AGI is farm income

## **CRP** Payments

Participants are eligible for four types of USDA payments:

- Signing Incentive Payment- A one-time payment • of \$100 per acre. USDA makes this payment within 30 days after the contract has been approved
- Annual rental payments based on the relative productivity of the soils within the offered area and the average dryland cash-rent or cash-rent equivalent
- Cost share assistance of 50 percent for installing the practice on contracted land
- Practice Incentive Payment- Approximately 40 percent of the total cost for establishing the practice

## Management

Participants are required to perform mid-contract management activities. These activities serve to

increase the diversity of the habitat during the contract lifespan. This could include disking, mowing, burning, and interseeding. A 50 percent cost-share payment is paid in the year the management Ring-necked Pheasant

is performed.



## Monitoring and Compliance

#### Monitoring

The Wisconsin Department of Natural Resources (DNR) will complete monitoring activities for all SAFE practices. These reviews will determine the success of the practice in accomplishing the stated goals.

Annual reports will be submitted to the National FSA Office. Monitoring for goal success is separate and distinct from participant compliance obligations.

#### Compliance

SAFE practices are implemented through the Farm Service Agency's Conservation

**Grasshopper Sparrow** 

Reserve Program (CRP) and are therefore subject to all CRP regulations, including but not limited to:

- Control of noxious weeds
- Control of any vegetation not prescribed by the conservation plan
- Establishment and maintenance of the cover as • stipulated by the contract and conservation plan
- Adherence to primary nesting season policies (May 15–August 1)
