## Farm Service Agency (FSA) Power of Attorney Rules

Proper Form: Form FSA-211, Power of Attorney

<u>Witnessed Signature</u>: The grantor's signature on the FSA-211 must be acknowledged by a Notary Public or witnessed by a FSA employee.

**Note:** If the grantor is a corporation, the corporate seal may be used in lieu of a witness.

<u>Authorizations</u>: Grantors may authorize the attorney-infact to act on their behalf for all or specific:

- FSA or CCC programs
- · permissible transactions
- crop insurance transactions
- farms.

<u>Prohibited Transactions</u>: A FSA-211 does not allow the attorney-in-fact to act on behalf of the grantor to:

- file another FSA-211 for the grantor
- · participate in the COC election
- request electronic access.

Other Transactions: The following transactions are **only** allowed if specifically granted on the FSA-211:

- · routing payments to financial institution accounts
- · redeeming cotton pledged as collateral
- certifying adjusted gross income.

#### **Frequently Asked Questions**

 Can any member of a general partnership sign FSA documents if the partnership agreement does not specify or restrict signature authority?

Yes. Montana State law allows any partner to sign and bind the partnership under these circumstances.

2. Can any officer of a corporation sign FSA documents if the articles or bylaws do not specify or designate signature authority?

No, a board of directors' resolution designating the signatory must be provided to FSA.

**Note:** A FSA-211 can be provided to designate a member to act on behalf of the corporation.

3. For a corporation, can an agent (non-owner) be designated as a signatory?

Yes. If the person authorized to sign for the entity is permitted redelegation authority, then a FSA-211 may be submitted. If the entity documents do not allow for redelegation, the agent may be granted signature authority through a FSA-211 signed by all officers or by resolution.

4. Does the trust agreement have to specifically provide signature authority to a trustee?

No. A trustee has signature authority. If cotrustees are designated, all trustees must sign for the trust

5. Under spousal signature authority, can the spouse of a trustee act on behalf of the trustee?

No. The spouse may only act on behalf of the individual's interests.

6. Who can sign for a joint venture?

Each member of a joint venture must sign FSA documents. For a husband and wife joint venture, an individual may sign for their own interest and sign again for their spouse's individual interest.

# Can an individual sign FSA documents on behalf of another individual or entity?

Yes, as long as acceptable evidence of authority is on file with FSA. However, if a document is signed by an individual without signature authority, any payments or benefits resulting from the improper signature may have to be refunded.

# What documents must be provided as acceptable evidence of authority?

Legal documents designating signature authority. For most situations, a valid power of attorney may be provided if acceptable evidence of authority does not designate the signatory.

# What is a valid Power of Attorney (POA) for FSA purposes?

The FSA power of attorney form is the "FSA-211". This form must be signed and properly witnessed, and will remain effective until cancelled by the grantor, or either party dies, becomes incompetent or incapacitated, or if an entity, is dissolved.

**Note:** Under limited circumstances (active military duty, or incompetent or incapacitated individuals), a non-FSA POA may be provided.

Bottom line: Ensure FSA has your proper signature authorization on file!
