Continuous CRP Signup 46 (SU46) Software Changes

1 Overview

A Background

The Agricultural Act of 2014 (2014 Farm Bill):

- exempts AGI for contracts enrolled during continuous SU46
- has changed the applicable years for the CRP crop history requirement to 2008 through 2013.

MIDAS Farm Records implementation has prompted the need for system modifications for acreage processing in 100ths in the Tool for Environmental Resource Results Assessment (TERRA), Conservation On-Line System (COLS), and Conservation Contract Maintenance System (CCMS) beginning with continuous SU46.

B Purpose

This notice informs State and County Offices that the following software modifications are being implemented for continuous SU46:

- COLS will allow the contract to be approved without an AGI certification
- crop history requirement has been updated to reflect years 2008 through 2013 in COLS
- TERRA, COLS, and CCMS will process acreage in 100ths.

2 Software Changes for Continuous SU46

A COC Approval in COLS

AGI does **not** apply to continuous SU46 offers at COC approval. However, entity and member information **must** still be entered correctly in SCIMS and Business File **before** COC approval of the continuous SU46 offer in COLS. The following table provides corrective action if a user encounters a COLS display message at COC approval.

Important:

Software modifications are being made to **not** check AGI for continuous SU46 contracts; the system will still update the AGI flag in Conservation Payments to "Compliant". The change is being made in this manner to minimize the impact of the AGI exception for continuous SU46. Notification will be provided when this software modification has been made, on or about June 20, 2014. **Continuous SU46 offers cannot be approved in COLS until this software modification has been released.**

Note: AGI will **not** apply to any continuous SU46 offer.

If a COLS user receives 1 of the COLS display messages in this subparagraph at COC approval, the user shall ensure that the corresponding corrective action is taken.

County Offices shall ensure that subsidiary applications are updated properly according to 3-PL (Rev. 1).

If the user cannot approve a contract in COLS after following this subparagraph, the user shall alert the appropriate State Office specialist. If the State Office specialist cannot resolve the issue, contact Kelly Worley according to subparagraph 3 A.

2 Software Changes for Continuous SU46 (Continued)

B Crop History Year Requirement Change

The 2014 Farm Bill changed the crop history year requirements from 4 of 6 years between 2002 through 2007 to 4 of 6 years between 2008 through 2013.

C Acreage Processing Change From 10ths to 100ths

Beginning with continuous SU46, TERRA, COLS, and CCMS will process and pay acreage in 100ths. All signups before continuous SU46 will continue to process and pay acreage in 10ths.
