Overview 1

A Background

CRP acreage inconsistencies between CCMS and MIDAS Farm Records exist.

Correctly and promptly updating CRP contracts in CCMS and MIDAS will:

- prevent out-of-balance tracts that may result in overpayment situations where a producer is being paid on both base acres and CRP acres
- prompt a review of CCC-505 CRP reduction acres to ensure that bases are being restored • properly after a termination, which can prevent underpayments to producers
- facilitate contract revisions since CCMS relies on cropland tract totals from MIDAS •
- expose other problems of which the county may have been unaware of, such as duplicate • CLU records or incorrectly attributed cropland
- simplify acreage reporting for future years; that is, after the fields are delineated and an initial acreage report is loaded, the data rolls over to subsequent years.

B Purpose

This notice provides information to State Office conservation specialists, State Office GIS specialists and coordinators, and County Office employees about the following:

- CRP Comparison Tool •
- CRP acreage inconsistencies between CCMS and MIDAS Farm Records
- reporting issues in the PECD Contract and Application Issues SharePoint site.

2 CRP Comparison Tool

A Data Inconsistency Report

To provide an accurate assessment of the CRP acreage inconsistencies between CCMS and MIDAS Farm Records data, a CRP Comparison Tool has been developed. The Comparison Tool uses data from CCMS and MIDAS Farm Records to generate a report that identifies the following inconsistencies:

- the CRP contract is not found in the CRP software
- the CRP contract data is not found at the field level in MIDAS
- the CRP contract exists in both CCMS and MIDAS Farm Records, but the acres do not match
- the CRP contract exists in both CCMS and MIDAS Farm Records, but the CRP practice acres do not match
- the CRP contract exists in both CCMS and MIDAS Farm Records, but the expiration date does not match
- the CRP contract exists in both CCMS and MIDAS Farm Records, but the expiration date is inconsistent.

CCMS and MIDAS Farm Records data is generated biweekly and placed on the FSA GIS SharePoint site. A Statewide CLU python script and the following 2 documents are also available on the site:

- "Comparing CCMS Data to MIDAS"
- "Creating CRP Shapefiles from MIDAS Export".

Error Message From CRP Comparison Report	Description	Corrective Action
Contract not found in CRP Software	 A contract number was found in MIDAS, but that contract was not found in CCMS. Notes: In most cases, this is because a suffix was not updated in MIDAS. MIDAS does not have an option for entering CP38B with the 23A subpractice. Users should enter CP38B. This will get flagged as an inconsistency, but users do not need to fix these. 	CCMS is the system of record for contract numbers. Check the contract in CCMS to determine the correct contract number, including suffix, and ensure that the contract has not been terminated or expired. If it is determined that there is CRP-1 and the contract is valid but missing from CCMS, the County Office shall report this to the State Office and the State Office shall post the contract details and attach the copy of CRP-1 to the PECD Contract and Application Issues SharePoint site for correction. If it is determined that the contract number is incorrect in MIDAS, correct the contract number in the field level "CRP Data Assignment" block.

A County Office Action

County Offices shall ensure that:

- inconsistencies between CCMS and MIDAS Farm Records are corrected by August 15, 2014
- any issues found are reported to the State Office immediately.

B State Office Action

The State Office conservation specialist and GIS specialist shall coordinate their efforts to provide support to County Offices.

State Offices shall:

- ensure that County Offices:
 - compare contract information stored in CCMS to CRP data loaded at the field level in MIDAS on a regular basis
 - merge county CLU's into a single Statewide CLU layer
 - run the Create CRP Layer Tool to join the MIDAS CRP data with the Statewide CLU layer
