1 Overview

A Background

According to 2-CRP, subparagraph:

- 462 B, CRP annual rental payments shall be made, when authorized after October 1, for each effective year
- 801 A, retired or retiring owners and operators who qualify under TIP may be eligible to receive annual rental payments for up to two additional years
- 264 B, EFCRP annual payments are scheduled to be issued starting one year after the anniversary of the effective date of the contract.

B Purpose

This notice:

- advises State and County Offices that Conservation Systems will be shut down on September 26, 2014 for FY rollover and to prepare for the annual batch payment process
- provides State and County Offices with the upcoming schedule for payment processing for CRP, TIP, and EFCRP
- reminds State and County Offices that payment reports are now accessible through the Common Payment Reports System.

2 CRP Schedule

A 2014 CRP Contract Revisions

Annual rental payments for CRP 2014 will be available for signature on October 9, 2014. This allows additional time for users to approve CRP contracts with a status of "Revise in Process". Notice CRP-776 provides instructions for completing revisions due to acreage changes from tenths to hundredths. Delaying the CRP payment run gives the County Offices the requisite time needed to complete these revisions so CRP annual payments are issued properly.

B County Office Action

County Offices shall:

- use the prepayment report to resolve any outstanding reduction issues before the batch payment run on October 8, 2014
 - begin certifying and signing:
 - TIP and EFCRP payments in NPS on or about October 2, 2014.
- CRP annual rental payments in NPS on or about October 9, 2014
- use the nonpayment/reduction report to resolve issues that prevented or reduced payments after the batch payment run
- use the "Make NPS Payment" option in Conservation Payments once the issue causing the payment failure is corrected, if applicable.
