### Shutting Down CRES and Migrating Remaining AD-245's From CRES to Cost Share Software (CSS)

#### 1 **Overview**

#### A Background

Notice CRP-759 informed State and County Offices that CRES would be shut down in the future and instructed them to begin preparing for this transition by cleaning up existing AD-245's.

On or about May 26, 2015, CRES functionality on System 36 will be completely disabled. At that time, all CRP cost share (approval, payments, and maintenance) will have to be performed in CSS. All remaining AD-245's that will earn additional payments must be manually entered into CSS.

### **B** Purpose

This notice:

- notifies State and County Offices that CRES software on System 36 will be permanently • disabled on or about May 26, 2015
- provides directions for actions needed before CRES is permanently disabled •
- provides directions to manually migrate outstanding AD-245's that will earn payment into • CSS
- provides information for training materials for Program Provisioning and CSS •
- advises State and County Offices that overpayments to producers with CRP cost share • payments that were issued from System 36 CRES will be established manually in NRRS
- provides guidance to County Offices for manually establishing receivables in NRRS. •

# 2 ACP-301 Report Record of AD-862

## A ACP-301 Summary

County Office users shall follow the instructions in 1-CONSV, subparagraphs 331 A and B to access and print the ACP-301 Report before CRES software is disabled on or about May 26, 2015. The ACP-301 Report will be a reference to aid the County Office user in determining which AD-245's will need to be manually migrated to CSS. The ACP-301 Report will help users determine which AD-245's have been approved and have either of the following:

- no performance was recorded, but payments will be received
- partial performance was recorded, and additional payments will be received.

# **B** Example of ACP-301 Report (Continued)

• AD-245 has been "partially performed"

Note: This will have a "C/S Earned" amount, but no "Performance Date".

- "C", which indicates that AD-245 has been "cancelled"
- "**F**", which indicates that AD-245 has been "Finally Performed". This will have a corresponding "C/S Earned" amount and a "Performance Date".

## C Actions for Existing AD-245's

For AD-245's currently maintained in CRES that will receive payment, the following actions shall be followed.

IF any AD-245's on the ACP-301 Report that have a status of	THEN they shall be
"A" = Approved, and <b>will</b> be paid	processed in CSS on or about May 26, 2015.
"P" = Partially Performed, and will receive additional payments

### 5 Establishing Receivables for CRP Cost Share

#### A Receivables for Overpayments

If a producer is determined to have been overpaid for a CRP cost share payment that was issued from System 36 CRES, County Offices shall establish the receivable manually in NRRS according to 64-FI using program code "XXAUTOCRPCS". "XX" is the year CRP-1 became effective.

State Offices shall:
