1 Overview

A Background

The 2006 emergency supplemental appropriations, (2006 Act) provided emergency funding and new authorities for ECP. The 2006 Act made eligible oyster, poultry, and nursery producers and private nonindustrial forest landowners. This new authority required different practices and a new form to address poultry growers who had damage to their poultry houses.

On June 15, 2006, the President signed into law which, among other things, transferred funding and authority for the rehabilitation of oyster reefs from ECP to the Department of Commerce, National Oceanic and Atmospheric Administration.

B Purpose

This notice provides:

- the practice write-ups needed to address new ECP requirements for poultry and nursery producers and forest landowners (Exhibit 1)
- FSA-849 and instructions (Exhibit 2) for poultry growers who suffered damage to their poultry houses, from hurricanes during calendar year 2005 and who have or will receive insurance payments for their poultry houses.

2 Action

Other Emergency Conservation Measures

EC7-DR Debris Cleanup – Nurseries and Other Structures

A Purpose

The purpose of this practice is to help producers recover from damages caused by hurricanes during the 2005 calendar year by cleaning up structures such as poultry houses, and in the case of nursery producers, removing debris, such as nursery structures, shade houses, and above ground irrigation facilities.

B Eligibility

Poultry and nursery producers who had damage from hurricanes during the 2005 calendar year to structures such as poultry houses or nursery structures are eligible for ECP assistance.

Assistance in nurseries is limited to removing debris such as shade-houses, above ground irrigation facilities, and nursery structures.

C Approved Measures

Costs associated with debris cleanup of poultry house structures are eligible for ECP assistance.

Notes: A <u>poultry house structure</u>, for purposes of this practice, is defined as a structure used to house poultry that are actually, normally, and routinely sold in commercial quantities for food, fiber, or eggs.

Commercial quantity means a quantity per week that would exceed \$100 in sales.

Costs associated with debris cleanup in nurseries for nursery structures, shade-houses, and above ground irrigation facilities are eligible for ECP assistance.

Costs to haul to landfill debris that cannot either be burned or buried will be eligible for ECP assistance. These costs include official landfill disposal fees.

Costs associated with removing hazardous waste material to an approved EPA landfill, including hauling and tipping or dumping fees, are not eligible.

Costs associated with structures such as homes or residences are **not** eligible for ECP assistance.

ECP cost-share assistance is limited to debris cleanup only. There is no assistance for restoration measures.

D Cost Share Policies

Cost-share assistance shall be based on 90 percent of the cost of debris cleanup, not to exceed an amount deemed appropriate by COC with approval from STC or its representative.

EC7-DR Debris Cleanup – Nurseries and Other Structures (Continued)

E Signup Period

STC shall establish the initial signup period for this practice. The signup period shall be from 30 to 60 days. If additional time is warranted, STC may approve up to an additional 60 day signup period.

F Technical Responsibility

Technical responsibility for this practice is assigned to FSA. FSA shall use all available resources in ensuring that ECP practices are completed in a timely and efficient manner.

G Lifespan

There is no practice lifespan for this practice.

EC7-F Forestry

A Purpose

The purpose of this practice is to provide private nonindustrial forest landowners cost-share assistance to rehabilitate and reforest commercial forest land that suffered damage from hurricane during the 2005 calendar year.

B Eligibility

An <u>eligible producer</u> is a private nonindustrial forest landowner who suffered a loss of, or damage to, at least 35 percent of forest acres on commercial forest land on a tract by tract basis.

<u>Private nonindustrial forest landowner</u> is defined as an individual, group, association, corporation, Indian Tribe, other legal entity, or person who receives concurrence from the landowner for practice implementation and who holds a lease on the land for a minimum of 10 years. Corporations whose stocks are publicly traded or owners principally engaged in the primary processing of raw wood are ineligible for ECP assistance under this practice.

<u>Loss</u> is defined as the difference between the pre-hurricane economic value of the trees and the post-hurricane economic value of the remaining trees, and is determined by a site visit by a natural resource professional, such as a State Forestry agency representative.

<u>Commercial forest land</u> is land with trees intended to be harvested for commercial purposes and that has a productivity potential greater than or equal to 20 cubic feet per year of merchantable timber.

C Approved Measures

Cost sharing is authorized for the following measures as required in the forest management plan:

- debris removal
- site preparation
- establishing a forestry plantation that will indicate the tree species best suited to the site

Note: Natural regeneration may be permitted if included in the forest management plan.

- temporary cover
- use of herbicides and insecticides necessary to establish the trees. Chemicals used in performing this practice must be Federally, State, and locally registered, and must be applied in accordance with authorized uses, directions on the label, and any other Federal or State policy or guidelines.

EC7–F Forestry (Continued)

D Policies for Practices

There must be a forest management plan, prepared by a State Forestry representative, which will provide all of the practice requirements to be completed on the land.

The State Forestry representative shall determine the percent of loss or damage (must be 35 percent or greater, per tract, to qualify for ECP assistance) and the applicable practices to be completed in the forest management plan. The forest management plan will address only land damaged by hurricanes during calendar year 2005.

The area treated must be protected from destructive fire or grazing.

E Cost Share Policies

The producer has 5 years from the date of the loss to:

- reforest the lost forest acres in accordance with a forest management plan, prepared through the State Forestry representative, that is appropriate for the forest type
- use best management practices in accordance with State Forestry representative's best management practices
- exercise stewardship on the forest land while maintaining the land in a forested state.

Cost sharing is authorized for up to 75 percent of the participant's actual cost or of the total allowable cost.

Cost share assistance is limited to \$150 per acre.

F Signup Period

STC shall establish the initial signup period for this practice. The signup period shall be from 30 to 60 days. If additional time is warranted, STC may approved up to an additional 60 day signup period.

G Technical Responsibility

Technical responsibility is assigned to the State Forester.

EC7–F Forestry (Continued)

H Lifespan

The timber stand must be maintained for a minimum of 10 years after planting.

EC7-PH Poultry House Reconstruction

A Purpose

The purpose of this practice is help poultry growers reconstruct or repair damages to their poultry houses.

B Eligibility

Only poultry growers who had damage to poultry houses from hurricanes during the 2005 calendar year are eligible. Assistance is limited to the uninsured or underinsured losses to poultry houses.

C Approved Measures

Costs associated with the reconstruction or repair of a poultry house, such as building costs, ventilation systems, heating and cooling systems, watering and feeding systems, and nesting systems.

All approved measures must comply with State and local ordinances, regulations, and building codes.

D Cost Share Policies

The total amount of assistance paid by FSA to a poultry grower under the ECP and any indemnities for losses to a poultry house (insurance payments) may not exceed 90 percent of the total costs associated with the reconstruction or repair of the poultry house.

Cost-share assistance shall be no more than 50 percent of the cost of reconstructing or repairing the poultry house and shall be limited to a maximum of \$50,000 per poultry house.

Examples:

A producer reconstructs a poultry house for a total of \$150,000. The insurance company paid the grower \$100,000 for the poultry house loss. ECP may pay 50 percent of the cost of reconstructing the poultry house (\$75,000) up to \$50,000. However, because of the limitation on 90 percent of the total cost of reconstruction or repair, the maximum ECP payment will be \$35,000 (\$150,000 times 90 percent equals \$135,000).

A producer rebuilds a poultry house for \$120,000. The producer received an insurance payment of \$10,000. 90 percent of the total cost is ($$120,000 ext{ x}$ 90 percent) \$108,000. The maximum ECP payment is 50 percent of the total cost ($$120,000 ext{ x}$ 50 percent = \$60,000) or \$50,000 whichever is lesser. The producers E7-PH payment is \$50,000.

EC7-PH Poultry House Reconstruction (Continued)

D Cost Share Policies

EC7-PH will **not** be used to increase the size of or improve the condition of the poultry house beyond what existed before the hurricane. The producer is responsible for costs associated with the increase in size or improvement in the operation.

Examples:

Before the hurricane disaster, a poultry grower had a 20,000 sq. ft. house. The grower decides to expand the house to 30,000 sq. ft. The producer uses the same materials, type of structure and systems to reconstruct the poultry house. EC7-PH will only provide assistance for what it would have cost to reconstruct or repair a 20,000 sq. ft. house.

Before the hurricane disaster, a poultry grower had a 20,000 sq. ft. broiler house that had poultry netting for walls, standard water misting, and exhaust fan ventilation. The poultry grower rebuilds the broiler house with solid walls, cool cells, and tunnel ventilation. FSA would only provide cost share in the amount it would have taken to replace the poultry netting, standard water misting, and exhaust fan ventilation.

Applicants shall inform FSA of any insurance payments received or to be received for the poultry house. Failure to inform FSA of such payments may result in a denial of, or demand for refund of, ECP payments. Insurance payment received after EC7-PH payment must be declared and the EC7-PH payment adjusted accordingly.

E Signup Period

STC shall establish the signup period for this practice. The signup period shall be from 30 to 60 days. Any extension of signup shall be submitted to the ECP-Program Manager (ECP-PM) for approval and shall include a justification for the extension.

F Technical Responsibility

Technical responsibility for this practice is assigned to FSA. FSA shall use all available resources in ensuring that ECP practices are completed in a timely and efficient manner. FSA may consult with integrators, CSREES, or other suitable expert for technical assistance advice.

G Lifespan

There is no lifespan for this practice.
