1 Overview

A Background

Financial Inquiries allows users to access a producer's financial information online. Access is provided to the following based on the eAuthentication user ID:

- County Office employees
- FSA/CCC Farm Program producers.

Financial Inquires provides customer service to producers by allowing instant access to financial information such as payments, collections, debt, and CCC-1099-G data, thus reducing the need to request information from the local County Office.

County Office employees with access to Financial Inquiries can answer producer's questions and view financial information in the same format that the producer is viewing.

Beginning with calendar year 2012 IRS reporting, Kansas City will:

• **not** generate and mail CCC-1099-G to producers if the total of reportable payments for the tax identification number is less than \$600

Exception: CCC-1099G **must** be issued to each producer who has Federal income tax withheld regardless of the total payment amount.

- issue one CCC-1099-G to multi-county producers whose total reportable payments for the tax identification number are equal to or greater than \$600
- Financial Inquires will continue to display all payment data, regardless of the producer's total reportable payments.

Note: Financial Inquiries does not identify which producers received CCC-1099-G. Whether or not a producer received CCC-1099G can be determined according to logic in this subparagraph.

To log into Financial Inquiries, perform the following:

- access FSA's Intranet Home Page at http://fsaintranet.sc.egov.usda.gov/fsa
- under Resoures, CLICK "FSA Applications"
- scroll down and under Financial Services, CLICK "Financial Applications"
- on FSA's Intranet Financial Applications Screen, CLICK "FSA Financial Inquiries"
- Security Alert dialog box may be displayed, CLICK "OK"
- the eAuthentication Warning Screen will be displayed, CLICK "I Agree"
- the eAuthentication Login Screen will be displayed, enter valid eAuthentication user ID and password and CLICK "Login" or CLICK "Login with my LincPass" to login with Lincpass Certificate.

3 1099/Refund Reports Selection

A 1099/Refund Reports Selection Updates

An option has been added to the CCC 1099 Inquiry Selection Screen to allow users to select "All" from the "Originating Office" drop-down menu for multi-county producers. This option allows users to select all States and counties associated with the producer tax ID number.

Note: The "All" option is only available for multi-county producers.

A 1099/Refund Reports Selection Updates (Continued)

The following statements have been added to the CCC 1099 Inquiry Selection Pages:

• "Beginning with CY 2012 and forward, 1099-G will not be issued to producers whose total payments are under \$600.00"

Exception: CCC- 1099-G **must** be issued to each producer who has Federal income tax withheld, regardless of the total payment amount.

• "Refund data is not shown on the 1099-G and is not reported to the IRS".
