1 Overview

A Background

The final rule for the LC Guarantee Program was published December 2, 2011. Since that time, there has been limited interest in this program. FSA offers LC Guarantees to the owner of a farm who wishes to sell real estate using LC to a beginning or SDA farmer or rancher. This program is a valuable tool to transfer farm real estate to the next generation of farmers and ranchers.

In some areas of the country, the availability of escrow or servicing agents to close and service LC Guarantees is limited. The inability of sellers to find an escrow or servicing agent severely limits use of this program.

Increased marketing efforts by FSA will ensure that more potential sellers and buyers are aware of the LC Guarantee Program. FSA remains committed to assisting beginning and SDA farmers and ranchers through this program.

This notice provides guidance on the following:

- available LC Guarantee escrow or servicing agents
- informing interested parties of available escrow or servicing agents
- LC Guarantee Program marketing.

2 Action

A Available LC Guarantee Escrow or Servicing Agents

Exhibit 1 lists agents who have indicated they will act as an escrow or servicing agent for LC Guarantees throughout the nation.

B Informing Interested Parties of Available Escrow or Servicing Agents

County Offices:

- can provide any interested party with a copy of Exhibit 1
- are to inform the interested party that:
 - the escrow or servicing agents listed are for informational purposes
 - FSA is **not** endorsing or recommending any particular agent.

Note: Any escrow or servicing agent who meets the conditions in 6-FLP, subparagraph 184 A may be used by the seller of the real estate.

C LC Guarantee Program Marketing

There may be eligible buyers or sellers who are not aware of the LC Guarantee Program. Additional marketing efforts by FSA will ensure that eligible buyers and sellers are aware of the LC Guarantee Program.

LC's may be part of the estate planning process, such as parents selling farmland to their son or daughter. Financial institutions, tax professionals, attorneys, and escrow agents are involved in implementing many LC's.

State and County Offices should ensure that these professionals are aware of the LC Guarantee Program by providing:

• estate planning professionals with LC Guarantee Program information and/or giving a presentation during an estate planning informational meeting
