

1 Cancellling Debt Without Application

A Background

FSA-2731 and 2731A were issued to replace RD-1956-1 for settlement of debts when a signed application is not required.

B Purpose

This notice:

- provides FSA personnel procedures to cancel debts that do not require a signed application
- obsoletes Notice FLP-675 without significant changes.

C State and County Office Action

FSA-2731 shall be used to cancel debts that do not require a signed application or to supplement the information on RD-1956-1 for any borrower who is not required to submit a signed application.

FSA-2731A may be used when an account has more than 4 borrowers.

2 Using FSA-2731 and FSA-2731A

A Authority

SED's may approve or reject:

- cancellations of accounts where all obligors are properly included on FSA-2731, or were previously released using FSA-2080, without regard to the size of the debt
- proposed debt settlements that require using RD-1956-1 (with or without FSA-2731) when the outstanding balance of the indebtedness involved in the settlement, less the amount of any compromise or adjustment offer, is less than \$1 million (including principal, interest, and other charges).

The Administrator, or designee, must approve or reject debt settlements that require using RD-1956-1 (with or without FSA-2731) when the outstanding balance of the indebtedness involved in the settlement, less the amount of any compromise or adjustment offer, is \$1 million or more (including principal, interest, and other charges).

When FSA-2731 is used with RD-1956-1, the settlement code for the account (3K transaction) will be for the settlement approved on RD-1956-1. Settlement of the debt will be approved on RD-1956-1.

B Effect on Current Handbook and Instructions

RD Instruction 1956-B, sections 1956.57(f) [County Committee], 1956.75 [Chargeoff] and 1956.84(a) [Approval Authority] are obsolete.

Note: Except as provided by this notice, RD Instruction 1956-B and 5-FLP, Part 24 and Exhibits 15, 16, and 36 remain in effect. Material in the referenced 5-FLP sites and reference to FSA-2731 will soon be relocated to 7-FLP. Material in RD Instruction 1956-B will be moved to 7-FLP after CFR is revised.
