**1 2013 MAL's and LDP's**

**A Background**

The 2008 Food, Conservation, and Energy Act of 2008 (2008 Act) expired with the 2012 crop year. The 2008 Act authorized 2008 through 2012 crop MAL's and LDP's on barley, canola, corn, crambe, dry peas, flaxseed, grain sorghum, honey, large chickpeas, lentils, mohair, mustard seed, oats, peanuts, rapeseed, rice, safflower, sesame seed, small chickpeas, soybeans, sunflower seed, wheat, and graded and non-graded wool.

The American Taxpayer Relief Act of 2012, signed by the President on January 2, 2013, extended MAL's and LDP's for the 2013 crop year.

**B Purpose**

This notice authorizes crop year 2013 MAL's and LDP's, if applicable.

All policies and procedures currently in the following are still effective:

- 8-LP, except for mohair
- 2-LP Honey
- 2-LP Rice.

### 1 2013 MAL's and LDP's (Continued)

#### C Crop Year 2013 Wool

This notice:

- instructs State and County Offices that:
  - applications for wool MAL's and LDP's, if applicable, for crop year 2013 may be accepted upon receipt of this notice
  - program codes for wool MAL's and LDP's, if applicable, for crop year 2013 will be available later this month

**Notes:** The applicable program code for crop year 2013 wool MAL's will be available later this month. Until available in the software, crop year 2013 wool MAL's cannot be:

- entered into APSS
- disbursed.

The Consolidated and Further Continuing Appropriations Act of 2012 suspended funding for mohair MAL's and LDP's through FY 2012. The Continuing Appropriations Resolution 2013 extended the suspension for mohair. **Therefore, crop year 2013 mohair MAL's and LDP's are not authorized.**

Unshorn pelts are eligible for LDP but **not** for MAL.
