

Program Purpose

The Drought Emergency Conservation Program (ECPD) provides cost-share assistance during periods of drought to supply emergency water in pastures where the previously adequate water source has failed.

Eligibility

A failed water source must be located in the pasture where the new ECPD practice is being installed. To be eligible for ECPD, a practice must primarily serve grazing land and grazable vegetation must be available.

Practices

Emergency practices include:

- ◆ **Practice EC-6:** Pipelines, tanks, troughs, constructing or deepening wells, and spring developments.
- ◆ Submersible pump. (Pressure tank, valves, gages, etc., not eligible for cost-share.)
- ◆ **Practice EC-7:** Water hauling for **CONTRACTED LABOR** (hauling water, holding tanks, troughs, truck rental for delivering water, the labor for delivering water, and pipelines.) A producer **CANNOT** receive cost-share for his/her own equipment. Cost-share assistance is allowed for leased or contracted equipment and applicants labor.

What The Producer Needs To Do To Apply For ECPD

- ◆ Mark on your map:
 - border fences
 - cross fences
 - existing water sources
 - failed water sources (for dams, add years failed and water source used since that date.)
 - new project
- ◆ Estimate the cost of the new project.
- ◆ If you install tanks, troughs, pipelines or springs, contact the Natural Resources Conservation Service (NRCS) with project specifications or if you need further assistance on

the project, they will be happy to assist you with your needs.

Then What Happens.....

After the inspection, and NRCS/ FSA concurrence, the FSA County Committee may issue an approval.

The practice must be completed 60 days following approval. Work may begin as soon as the application process is completed.

Completion of the Project

Following completion of the project:

- ◆ Notify your local FSA county office and submit any bills or receipts from the project. Sign form AD-245.
- ◆ If you do the work yourself, submit a signed log of the hours and type of work that was completed.
- ◆ You will be required to show that all invoices and/or bills have been paid. This may be done with a copy of cancelled checks, a copy of a credit card receipt, or a written statement from the contractor or supplier that the bills have been paid.
- ◆ A project inspection will be conducted by NRCS or FSA and a cost-share payment may be issued.




Additional Information

- ◆ Cost-share rate is 75 percent of actual costs for temporary practices and 50 percent of actual costs for permanent practices, not to exceed the established maximums.
- ◆ All practices must be done according to NRCS specifications. However, some components of certain practices are not eligible for FSA cost-share.
- ◆ Permanent practices must be maintained for 10 years and are subject to spot check during that time. If the practice is not working, or is being used for ineligible purposes, cost-share may be required to be refunded.
- ◆ The FSA County Committee may limit cost-share based on acres served. Projects are not eligible on grazing land that has more than 50 percent cropland in a pasture.
- ◆ If you have an approved practice and later decide to change that practice, the extents, or the location, you must contact the FSA office prior to changing to see if the practice approval will still apply.
- ◆ Projects on federal land are only eligible if the project serves private land.

Additional Information

- ◆ If the project has been started or completed, please contact your local FSA office to see if the project will still meet cost-share eligibility.
