USDA REPORTS COMMODITY LOAN ACTIVITY AS OF MARCH 3, 1998

WASHINGTON, March 10, 1998 -- A report of commodity loan activity for grains, cotton, oilseeds, honey and sugar as of March 3, 1998, was issued today by the U.S. Department of Agriculture, Farm Service Agency (FSA).
