SUBJECT: LOCATION OF APPEAL HEARINGS

TO: State Directors, District Directors, and County  
Supervisors

PURPOSE/INTENDED OUTCOME:

The purpose of this FmHA Administrative Notice (AN) is to update the list of hearing locations where the National Appeals Staff will conduct appeal hearings in each State. The intended outcome is the improvement of the scheduling of hearings and use of time and resources. Appellants will not have to travel more than 100 miles to attend hearings, and more hearings may be held by each Hearing Officer. Specific hardship cases will be handled on a non-routine basis.

COMPARISON WITH PREVIOUS AN:

This AN supercedes AN No. 2005 (1900) by deleting some hearing locations and adding others based on transportation costs, availability of hearing rooms, and geographic obstacles (e.g., mountains).

IMPLEMENTATION RESPONSIBILITIES:

The attached list of States with hearing locations will be used by the National Appeals Staff in order to conduct hearings on appeals filed pursuant to FmHA Instruction 1900-B. The appellants and the FmHA decision makers will be required to travel to the designated sites for the hearings. Hearing Officers may spend a week in the designated location and conduct as many hearings as is prudent and feasible on appeals from appellants who live within 100 miles of that location in that State. The FmHA decision makers will be required to arrange their schedules to attend the hearings set up for those locations. If they cannot attend, they must send an informed representative.


