### **USDA REPORTS COMMODITY LOAN ACTIVITY AS OF MARCH 24, 1998**

WASHINGTON, March 31, 1998 -- A report of commodity loan activity for grains, cotton, oilseeds, honey and sugar as of March 24, 1998, was issued today by the U.S. Department of Agriculture, Farm Service Agency (FSA).

The data in this weekly report are preliminary and subject to adjustment and verification. Any needed adjustment will be made in the monthly reports of loan activity which USDA issues on or about the 10th working day of the month, depending upon availability of data.
