



FSA AT WORK ACROSS IDAHO 2015

Commodity Program Payments: \$255.3 million

Idaho producers received substantial monetary support during FY 2015 in the form of commodity and price support program payments.

\$518,808 - Direct and Counter Cyclical Program (DCP)

Direct payments provide income support to producers of eligible commodities based on production history (acreage and yields) and do not depend on the current production choices. Counter-cyclical payments are made when the effective price for eligible commodities is less than the target price.

\$59,954 - Average Crop Revenue Election Program (ACRE) provides revenue-based payments as an alternative to receiving price-based counter-cyclical (CC) payments.

\$3,964 - Margin Protection Program (MPP-Dairy) offers protection when the difference between the all milk price and the average feed cost (the margin) falls below a certain dollar amount selected by the producer.

\$1,557,001 - Farm Storage Facility Loans (FSFL) The Commodity Credit Corporation (CCC), through FSA, may make loans to producers to build or upgrade farm storage and handling facilities for eligible commodities.

\$253,196,673 - Commodity Loans are available to eligible producers who use crops as collateral. The Commodity Credit Corporation (CCC) makes loans for eligible commodities that are farm or warehouse stored.

Conservation: \$37.1 million

FSA made significant investments toward conserving and improving soil, water, and wildlife resources in Idaho. Conservation investments in FY 2015 include:

\$34,589,345 - Conservation Reserve Program (CRP) provides financial incentives, cost-share and rental payments to producers who convert highly erodible cropland or environmentally sensitive acreage to long-term vegetative cover.

\$192,470 - Emergency Conservation Program (ECP) provides emergency funding for farmers and ranchers to rehabilitate farmland damaged by natural disasters and carry out emergency water conservation measures during periods of severe drought.

2,246,091 - Grassland Reserve Program (GRP) is a voluntary program designed to protect grasslands from conversion to cropland or other uses and conserve valuable grasslands by maintaining viable ranching operations.

\$75,392 - The Biomass Crop Assistance Program (BCAP) provides financial assistance to owners and operators of agricultural and non-industrial private forest land who wish to establish, produce and deliver biomass feedstocks.

Disaster Assistance: \$23.8 million

From drought to flood, freeze and tornadoes - FSA was financially responsive to Idaho producers following natural disasters.

\$681,891 - Non-Insured Crop Disaster Assistance Program (NAP) provides financial assistance to producers of noninsurable crops when low yields, loss of inventory, or prevented planting occurs due to natural disasters.

\$20,588,866 - Livestock Forage Program (LFP) provides compensation to eligible livestock producers who have suffered grazing losses for covered livestock on land that is native or improved pastureland with permanent vegetative cover or is planted specifically for grazing.

\$142,215 - Livestock Indemnity Program (LIP) provides partial reimbursements to eligible livestock owners for livestock losses suffered due to a natural disaster or other emergency.

\$50,166 - Tree Assistance Program for Orchardists and Nursery Tree Growers (TAP) provides financial assistance to replant or rehabilitate eligible trees, bushes and vines damaged by natural disasters.

\$2,302,005 - Emergency Assistance for Livestock, Honeybees and Farm-Raised Fish Program (ELAP) provides emergency assistance to eligible producers of livestock, honeybees and farm-raised fish that have losses due to disease, adverse weather or other conditions.



Farm Loans: \$98.9 million

FSA offers various loan options to Idaho farmers and ranchers who manage family-sized operations and who were temporarily unable to obtain private or commercial credit.

\$59,551,994 - Guaranteed Loan Program FSA guarantees loans made by conventional agricultural lenders for up to 95 percent of any loss if the loan fails. In FY 2015, FSA guaranteed 69 farm ownership loans and 181 operating loans including 113 loans to beginning producers and nine loans to targeted underserved producers.

\$477,000 - Emergency Loan Program helps producers recover from production and physical losses due to drought, flooding, other natural disasters, or quarantine. In FY 2015, five Emergency Loans were issued.

\$35,095,254 - Direct Loan Program FSA provides assistance to those unable to obtain guaranteed loans. In FY 2015, FSA funded 89 farm ownership loans and 329 operating loans, including 130 youth loans, 356 loans to beginning producers and 150 loans to targeted underserved producers.

\$3,773,366 - Microloans are direct farm operating loans with a shortened application process and reduced paperwork designed to meet the needs of smaller, non-traditional, and niche type operations. In FY 2015, 151 Microloans were issued.
