Greetings to you all! Oregon is experiencing quite a rainy and snowy spring which might be affecting our planting season but hopefully will benefit our farms and fields throughout the remaining year. If you do suffer damages due to inclement weather, a severe storm or drought, please contact your local <a href="USDA Service Center">USDA Service Center</a> to make a report and find out what programs might be available. Resources are also available on the Disaster Assistance Discovery Tool.

Recently, USDA announced new assistance for distressed borrowers that beginning in April it will provide \$123 million in additional financial assistance for qualifying farm loan program



borrowers who are facing financial risk, as part of the \$3.1 billion to help distressed farm loan borrowers that was provided through Section 22006 of the Inflation Reduction Act. # USDA Seeking Applications to Expand Conservation Assistance to Underserved Producers

The U.S. Department of Agriculture (USDA) is seeking applications for projects that will improve outreach to underserved producers and underserved communities about conservation programs and services and opportunities for students to pursue careers in agriculture, natural resources and related sciences. USDA's Natural Resources Conservation Service (NRCS) is offering up to \$70 million in cooperative agreements with entities for



two-year projects that encourage participation in NRCS programs, especially in underserved communities and among urban and small-scale producers. Proposals are due

# **USDA Provides Local Support for Beginning Farmers and Ranchers**

The first 10 years of a farming or ranching operation are tough. USDA recognizes you need dedicated support to help make sense of all the information coming your way. Now each state has a Beginning Farmer and Rancher team headed up by a state coordinator. The coordinator helps producers who have operated a farm or ranch for less than 10 years navigate USDA and partner resources.

#### **Applying for Beginning Farmer Loans**

The Farm Service Agency (FSA) assists beginning farmers to finance agricultural enterprises. Under these designated farm loan programs, FSA can provide financing to eligible applicants through either direct or guaranteed loans. FSA defines a beginning farmer as a person who:

- Has operated a farm for not more than 10 years
- Will materially and substantially participate in the operation of the farm
- Agrees to participate in a loan assessment, borrower training and financial management program sponsored by FSA
- Does not own a farm in excess of 30 percent of the county's average size farm.

# NRCS Oregon Accepting Proposals for 2023 Conservation Innovation Grants

The Natural Resources Conservation Service (NRCS) in Oregon announced up to \$300,000 is available for eligible individuals, local and state government, non-governmental organizations and tribes through the Conservation Innovation Grants (CIG) program. Project proposals are due by **May 8, 2023**.



The CIG program supports the development and adoption of innovative conservation approaches and technologies to solve conservation challenges. Projects must be within Oregon and may be area based or state-wide in scope.

The CIG proposal must involve Environmental Quality Incentive Program (EQIP) eligible producers and should demonstrate the use of innovative technologies or approaches to address a natural resource concern. Resource concerns addressed must fall into one of the following sub-categories: energy, air quality and atmospheric change, water quality or quantity, plant health/vigor, soil quality, and wildlife habitat. ## **USDA-NASS 2023 June Area Survey**



The June Area survey is one of the largest annual NASS survey projects and provides significant utility for the entire NASS survey

program. The data collected are used to supply direct estimates of acreage and measures of sampling coverage.

This survey utilizes an area sampling frame. The area frame consists of all land, stratified by land use, in all states except Alaska. The primary sampling units (PSU), based on land area, provide complete coverage of all agriculture activity occurring on that land and, therefore, all operators in the state.

A sample of over 9,000 segments, smaller units of a PSU measuring roughly one square mile, is selected from each land use stratum for data collection. All farm operators operating within the boundaries of the selected segments are interviewed. In a given year, approximately 70,000 agricultural and non-agricultural land use tracts are identified within the sampled segments. From that identification, over 30,000 detailed interviews are conducted with farmers operating farms inside the segment boundaries or who have the potential to qualify as a farm.

Every five years, over 3,000 extra segments are sampled to supplement census coverage measures. For further information please visit the USDA National Agricultural Statistics Service website at USDA - National Agricultural Statistics Service - Surveys - June Area.
