### Office Notes

With most of the crops in planted it's time to start thinking about reporting your acreage to our office. At this time, we will be making appointments by phone to complete these. We can meet you at our picnic table beside the office to complete these or work with you over the phone and email to get them completed. Deadline for acreage reporting is **July 15, 2020**. Please contact our office as soon as you have completed your planting since this year's filing will be a little different.

We have received notice that the new Coronavirus Food Assistance Program (CFAP) signup will begin May 26, 2020 and run through August 28, 2020. Commodities included in the program are: Non specialty crops; Malt Barley, Corn, Oats, Soybeans, Sunflowers, and Hard Red Spring Wheat. Wool is also included. Livestock include, cattle, hogs, lambs and yearlings. For further details on this program you can visit [www.farmers.gov/cfap](http://www.farmers.gov/cfap).

Producers whose crops were affected by the fall snowstorm may be eligible for the WHIP+ program. This program is available for beans and alfalfa seed. Sugar beets were paid by the cooperatives and are not eligible for the FSA program.

If you have not completed your 2020 signup for the Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) program time is running out. Signup deadline for 2020 is **June 30, 2020**.

We have a lot of programs going on right now and with the COVID-19 we are working but can not allow producers in the office. We do have our picnic table beside the office that we can utilize to meet with producer's, or we can email or fax documents to you for your signature. We are here and ready to help with your sign up needs just give us a call and we will see what method will work best for you.

## USDA Reports Record Enrollment in Key Farm Safety-Net Programs

---

Producers signed a record 1.77 million contracts for the U.S. Department of Agriculture's Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs for the 2019 crop year, which is more than 107 percent of the total contracts signed compared with a 5-year average. USDA also reminds producers that June 30 is the deadline to enroll in ARC and PLC for the 2020 crop year.

Producers interested in enrolling for 2020 should contact their FSA county office. Producers must enroll by **June 30** and make their one-time update to PLC payment yields by September 30.

FSA attributes the significant participation in the 2019 crop year ARC and PLC programs to increased producer interest in the programs under the 2018 Farm Bill and to an increase in eligible farms because of the selling and buying of farms and new opportunities for beginning farmers and military veterans with farms having 10 or fewer base acres. Enrollment for 2019 ended March 16.

USDA Service Centers, including FSA county offices, are open for business by phone only, and field work will continue with appropriate social distancing. While program delivery staff will continue to come into the office, they will be working with producers by phone and using online tools whenever possible. All Service Center visitors wishing to conduct business with the FSA, Natural Resources Conservation Service or any other Service Center agency are required to call their Service Center to schedule a phone appointment. ## Farmers and Ranchers in Wyoming Can Now Apply for Financial Assistance through USDA's Coronavirus Food Assistance Program

### *Online Tools and Toll-Free Number Available to Assist Producers*

Agricultural producers can now apply for USDA's Coronavirus Food Assistance Program (CFAP), which provides direct payments to offset impacts from the coronavirus pandemic. The application and a payment calculator are now available online, and USDA's Farm Service Agency (FSA) staff members are available via phone, fax and online tools to help producers complete applications. The agency set up a call center in order to simplify how they serve new customers across the nation.

Applications will be accepted through August 28, 2020. Through CFAP, USDA is making available \$16 billion for vital financial assistance to producers of agricultural commodities who have suffered a five-percent-or-

greater price decline due to COVID-19 and face additional significant marketing costs as a result of lower demand, surplus production, and disruptions to shipping patterns and the orderly marketing of commodities.

We also want to remind producers that the program is structured to ensure the availability of funding for all eligible producers who apply.

In order to do this, producers will receive 80 percent of their maximum total payment upon approval of the application. The remaining portion of the payment, not to exceed the payment limit, will be paid at a later date nationwide, as funds remain available.

Producers can download the CFAP application and other eligibility forms from [farmers.gov/cfap](https://farmers.gov/cfap). Also, on that webpage, producers can find a payment calculator to help identify sales and inventory records needed to apply and calculate potential payments.

Additionally, producers in search of one-on-one support with the CFAP application process can call 877-508-8364 to speak directly with a USDA employee ready to offer assistance. This is a good first step before a producer engages the team at the FSA county office at their local USDA Service Center.

### **Applying for Assistance**

Producers of all eligible commodities will apply through their local FSA office. Those who use the online calculator tool will be able to print off a pre-filled CFAP application, sign, and submit to your local FSA office either electronically or via hand delivery. Please contact your local office to determine the preferred method. Find contact information for your local office at [farmers.gov/cfap](https://farmers.gov/cfap).

Documentation to support the producer's application and certification may be requested after the application is filed. FSA has streamlined the signup process to not require an acreage report at the time of application and a USDA farm number may not be immediately needed.

### **Additional Commodities**

USDA is also establishing a process for the public to identify additional commodities for potential inclusion in CFAP. Specifically, USDA is looking for data on agricultural commodities, that are not currently eligible for CFAP, that the public believes to have either:

1. suffered a five percent-or-greater price decline between mid-January and mid-April as a result of the COVID-19 pandemic,
2. shipped but subsequently spoiled due to loss of marketing channel, or
3. not left the farm or remained unharvested as mature crops.
