## WEEKLY NATIONAL MARKET PRICE FOR WOOL AND MOHAIR

WASHINGTON, Sep. 15, 2009 - The U.S. Department of Agriculture's Commodity Credit Corporation today announced posted prices for wool, by region, and the national posted price for mohair. The effective repayment rate is the lower of either the 30-day average or weekly rate.
