Nominating petitions can be obtained at the Taos County FSA Office – 224C Cruz Alta Road – Taos, New Mexico, by filling out the **attached** Nominating Petition, signing and returning by no later than August 1, 2006.

Ballots will be mailed out to eligible voters November 3, 2006, and must be returned by December 4, 2006.

**NONINSURED CROP DISASTER ASSISTANCE PROGRAM (NAP)**

NAP covers losses to crops not covered by Federal Crop Insurance. Coverage is for rangeland, vegetables, hay crops, etc. To be eligible for NAP, you need to do the following:

Report crop acres to our office by no later than July 15.

Please be aware that State Committee Policy states that Notice of Loss (CCC-576) must be filed within 15 calendar days after disaster occurred or damage to crop becomes apparent. Failure to report timely will result in a loss of benefits.

Your crop loss must be greater than 50% of expected yield and you will be paid on 55% of the county price.

An appraisal must be completed prior to destroying the crop or putting the crop to another use. Contact this office for an appraisal.

The cost will be \$100 per crop unit not to exceed \$300 per county per producer. There is a \$900 maximum per producer.

Keep in mind, if you purchased NAP coverage, cattle must be kept out of hay fields from June 1 through September 30, to allow hay to grow and to be harvested.

Please review the **attached** page showing application closing dates for the various crops covered under the NAP.

**IMPORTANT INFORMATION:** If you applied for the Crop Disaster Program (CDP), and received payments, you are REQUIRED to purchase NAP coverage for the next two subsequent years for such crop(s).

Also, if you intend to have your cattle graze your hay field(s) instead of cutting the hay, before doing so, you will need to write a letter which will have to state, that you are aware that you need to leave 8' by 8' representative samples **PER** field and an appraisal is required at the time of the normal final harvest date, unless sufficient representative samples are placed in each field that is to be grazed. Representative samples required need to be 8' by 8' **PER** field. The total amount of representative samples needed depend on the number of acres on each field.

ACRES IN FIELD OR SUBFIELD	MINIMUM NUMBER OF SAMPLES NEEDED
0.1 - 10.0 acres	3
10.1 - 40.0 acres	4

Add one additional sample for each additional 40.0 acres (or fraction thereof) in the field or subfield.

**Please be sure to turn in your acceptable records of hay production, in writing, as soon as you finish harvesting your crops. Producers are responsible for reporting production on all NAP crops. If you do not report your production, your yields will be lowered and this will reflect on any applicable NAP payments. Continuity of records is required when calculating an approved yield. The records must be consecutive, without breaks.**

### **ENVIRONMENTAL QUALITY INCENTIVE PROGRAM (EQIP)**

USDA-NRCS Announcement– The FY2007 Environmental Quality Incentive Program (EQIP) application period is open and will continue until November 3, 2006. EQIP is a key program under the 2002 Farm Bill that provides cost-share funds to working farms and ranches for conservation improvements. EQIP, like all NRCS programs, is a voluntary program that is intended to yield high quality, productive soils; clean and abundant water; healthy plant and animal communities; clean air; an adequate energy supply; and working farms and ranchlands. The early deadline is a continuing effort to improve the funding process. The new program cut-off date will allow producers time to complete practices during the first years of their contracts. The earlier application deadline date will help accommodate field work in preparation for a project, to be done in the fall before winter weather sets in. ### **REPORTING CHANGES**

**IT IS THE RESPONSIBILITY OF EACH PRODUCER TO REPORT THEIR FARM OPERATION COMPLETELY AND ACCURATELY.**

IT IS ALSO THE **PRODUCER'S RESPONSIBILITY TO NOTIFY FSA OF ANY CHANGES IN THEIR FARMING OPERATION OR ENTITY STATUS THROUGHOUT THE YEAR.** Changes that may affect a determination include, but are not limited to a change in contract shares of a contract which may reflect change of land lease from cash rent to share rent or from share rent to cash rent; modification of the variable/fixed bushel rent arrangement; a change in the size of the producer's farming operation by the addition or deletion of a farm; a change in the structure of the farming operation, including any change in the member's shares; a change in the contributions of farm inputs of capital, equipment, active personal labor, or active personal management; and a change of farming interest not previously disclosed on CCC-502 or update, including the farming interest of a spouse or minor child.

Any producers who are determined "Not Actively Engaged in Farming" will be INELIGIBLE for most USDA payments, This includes DCP, gains from marketing loans and loan deficiency payments (LDPs), CRP annual rental payments, disaster assistance or emergency payments and any payment or benefit requiring a payment limitation determination.
