CONSERVATION RESERVE PROGRAM

Producers, who signed up for emergency grazing, may continue grazing CRP until November 30th, provided adequate cover exists.

DCP SIGNUP

Signup for 2007 DCP is underway. Producers are reminded that they must signup annually for DCP. Signup ends June 1.

Producers will begin receiving 2007 advanced, Direct payments in December.

NON-INSURED ASSISTANCE PROGRAM (NAP)

The deadline to purchase NAP coverage on native grass is Jan. 31. There are no late filing provisions.

Deadline for certifying native grass on which NAP is purchased is Feb. 14th.

MARKETING ASSISTANCE LOANS/LDP'S

Marketing Assistance Loans are available for commodities harvested as grain and certain oilseeds. Producers are reminded that production evidence is required on loans and LDP's.
