

#### Part 1 Basic Information

#### 1 Overview

#### A Handbook Purpose

This handbook contains guidance and procedure for EDW, which is an agency wide reporting warehouse, designed and managed by the Data Base Management Office. EDW will be a shared platform for Farm Programs, Farm Loan Program, and Financial Management Division and will be supported by the front end reporting tool OBIEE.

#### 2 Data Mart Updates and Errors

#### A Data Mart

A data mart is the access layer of the data warehouse or data vault environment that is used to make data available to the users. The data mart is a subset of the data warehouse/data vault that is usually oriented to a specific business line or team. Data marts are small slices of the data warehouse. Whereas data warehouses/data vaults have an enterprise-wide depth, the information in data marts pertains to a single department. This enables each department to use, manipulate, and develop their data any way they see fit; without altering information inside other data marts or the data warehouse.

#### **B** Report Data Updates

EDW will be updated on Monday through Saturday nights no earlier than 8pm E.T. Based on this schedule, users can expect to see the data that is updated in the source application to be reflected in the reports the following day. Data updated in the source application on a Sunday will not be reflected in the EDW report until Tuesday.

If updates fail to load on any night, users will be notified of those failures and any effects with an information bulletin.

#### **B** Access Levels

EDW access will be determined based on the OIP Code in the user's security profile. There will be three levels of access; National, State, and county. These three levels will guide the dashboards and reports the user is able to access based on their role.

# C Requesting Access

For the initial release of EDW, access has been granted to all applicable FSA employees. For access requests after the initial release, an FSA-13A will need to be submitted to security. See the table below for the applicable Role Name to be listed on FSA-13A.

#### 4 Data Accessibility

### 22 Filtering Options in EDW

#### A Overview

All reports will have the same basic functionality for filtering. A dashboard filter is interactive and is always displayed on the dashboard page so that the user can filter for different values without having to re-run the dashboard. The filters may be dependent on previous selections. For example, if a user selects an Associated State the Associated County values will be updated to only show the relevant counties to the state selected. All filters for a report will display when the user selects the report in the header.

Users do not need to make a selection for all filters. Once the desired prompts are entered, users shall CLICK "Apply" to generate the report. The State and County Office prompts will be defaulted based on the user role as outlined in paragraph 3 of this handbook.

### 24 Report Printing and Exporting

#### **A** Overview

EDW has standard printing and exporting options available for all reports. The options for printing or exporting are located at the bottom center of the screen. Users may need to scroll to the bottom of the screen to find this option.

Once the user clicks on the blue hyperlink to print or export, the following options will be displayed.

When exporting to any of the options, the number of lines of data are capped according to space available on desktop and format chosen for export. If users are exporting a large amount of data it is possible that not all data will be exported due to the volume. One workaround is to make two reports by splitting one State into two groups of counties and merging them together once exported.







## Exhibit 2

#### **Administrative County Office**

Administrative County Office is the County Office designated by FSA to:

- make determinations
- handle official records
- issue payments to producers.

#### **CCID/SCIMS ID Number**

<u>CCID/SCIMS ID number</u> means a unique number automatically assigned to each customer record.

#### **CRM (Customer Relationship Management)**

<u>CRM (Customer Relationship Management)</u> means the system within MIDAS which houses Business Partner and Farm Records.

#### Farm

A <u>farm</u> is made up of tracts that have the same owner and the same operator. Land with different owners may be combined if all the land is operated by 1 producer with all of the following elements in common and substantially separate from that of any other tracts:

- labor
- equipment
- accounting system
- management.

The minimum size required for land to be considered a "farm" for FSA program purposes is 1/100th of an acre. However, the land must be part of a farming operation, a business enterprise engaged in the production of agricultural products, commodities, or livestock, operated by a person, legal entity, or joint operation that is eligible to receive payments, directly or indirectly, under one or more USDA programs.

#### Field

A <u>Field</u> or CLU is the smallest unit of land that has:

- labor
- a permanent, contiguous boundary
- a common land cover and land management
- one common owner
- a common producer association.

#### **Definitions of Terms Used in This Handbook**

#### Operator

An <u>operator</u> is an individual, entity, or joint operation who is determined by COC as being in general control of the farming operations on the farm for the current year.

#### **Other Producers**

Other producers are producers who are:

- associated with a farm
- not owners or operators.

#### Owner

An <u>owner</u> is an individual or entity who has legal ownership of farmland, including individuals or entities that are any of the following:

- buying farmland under a contract for deed
- retaining a life estate in the property
- purchasing a farm in a foreclosure proceeding and all of the following apply:
  - the redemption period has not passed
  - original owner has not redeemed the property
  - a spouse in a community property State
  - spouses owning property jointly.

#### **OBIEE** (Oracle Business Intelligence Enterprise Edition)

<u>OBIEE</u> is a reporting tool developed by the Oracle Software company for enterprise reporting.

#### **Recording County**

<u>Recording county</u> means the County Office assigned the specific responsibilities for updating the eligibility and payment limitation data for a FSA customer. The recording county **cannot** be a CMA or LSA county and the producer **must** be linked to the county in SCIMS.

#### Tract

A <u>tract</u> is a unit of contiguous land that is both of the following:

- under 1 ownership
- operated as a farm or a part of a farm.
