Since COC elections happen only once a year, here is an election refresher. For election purposes, counties are divided into local administrative areas, or LAA's. Each LAA selects one producer to serve a three-year term on the Farm Service Agency county committee.

Each year, an election is held in an LAA to replace the committee member whose three-year term is expiring. In counties with three LAAs, one seat is up for election. In combined counties in some years, two seats may be up for election.

This year the election is being held in LAA #5. This LAA is South and East of the Snake River in Jefferson County.

Since a Committee member can only serve three terms, there is no incumbent this year. We wish to thank Roger Clark for serving on the Jefferson/Clark County Committee since 2001.

To be eligible to serve on the FSA County Committee, a person must participate or cooperate in a program administered by FSA, be eligible to vote in a county committee election and reside in the local administrative area in which the person is a candidate.

We encourage agricultural producers to nominate candidates including themselves, especially minorities and women, to serve on the FSA Committee.

FSA county committee members make decisions on disaster, conservation, emergency, commodity price support and loan programs and other important agricultural issues. Newly elected committee members and alternates take office January 1, 2010.

To be valid, the nomination form must be signed by the person being nominated, indicating agreement to serve if elected. The completed nomination form must be returned to the county office or postmarked by Aug. 3.

Voting

Agricultural producers of legal voting age can vote if they participate or cooperate in any FSA program. A person who is not of legal voting age but supervises and conducts the farming operations on an entire farm can also vote.

Crop Report Deadline June 30th

A crop report is required for all programs in 2009. You must file by **June 30th** to avoid paying any late file fees.

Crop reports include the crop planted, date planted and intended use.

DCP & ACRE Signup Deadline

Signup for the 2009 Direct and Counter-cyclical Payment (DCP) Program has been extended until August 14, 2009. FSA will not accept any late-filed applications. Signup in the ACRE option is also available through **August 14, 2009.**

FSA computes DCP Program payments using base acres and payment yields established for each farm. Eligible producers receive direct payments at rates established by statute regardless of market prices. For 2009, you may request to receive advance direct payments based on 22 percent of the direct payment for each commodity associated with the farm. Counter-cyclical payment rates vary depending on market prices and are issued only when prices fall below a threshold level.

The electronic DCP (or eDCP) service will save you time, reduce paperwork and speed up contract processing at FSA offices. It is available to anyone eligible to participate in the DCP Program. To access this on-line service, you must have an active USDA eAuthentication Level 2 account, which requires filling out an online registration form at <http://www.eauth.egov.usda.gov> followed by a visit to the local USDA Service Center for identity verification.

Changes in Payment Limitations

Anyone that plans to participate in 2009 programs is required to submit a completed CCC-902, CCC-926, and CCC-901, if applicable, for payment eligibility and payment limitation purposes. The form used prior to 2009 was named CCC-502.

All partners, stockholders, or members with an ownership interest in the legal entity must make an active contribution, whether compensated or **not** compensated. That active contribution must include:

- personal labor, or
- active personal management,
- or a combination of active personal labor and active personal management to the farming operation;

Note: that there are exceptions for spouses.

ISDA Seeking Specialty Crop Grant Applications

The Idaho State Department of Agriculture (ISDA) is pleased to announce the competitive solicitation process to award Specialty Crop Block Grant Program. The US Department of Agriculture has allocated these funds to the state and ISDA will be passing them through as competitive grants. Funds will be available to interested local, state, and federal government, non-profit and for-profit organizations, and universities as competitive grants.

Eligible projects will solely enhance the competitiveness of U.S. grown specialty crops in either domestic or foreign markets and projects must benefit more than one product or organization.

Projects may include, but are not limited to, pest and disease control, sustainability, enhancing food safety, improving efficiency and reducing costs of distribution systems, developing new and improved seed varieties, increasing child and adult nutrition knowledge and consumption of specialty crops; specialty crop research, and assisting all entities in the specialty crop distribution chain in developing "Good Agricultural Practices", "Good Handling Practices", "Good Manufacturing Practices", and in cost-share arrangements for funding audits of such systems for small farmers, packers, and processors.

"We are looking for quality projects that will have a significant and lasting impact on Idaho's specialty crop industry," commented Director Celia Gould, ISDA, "The evaluation committee will be looking for feasible proposals that will benefit a great number of producers with a good return on investment."

Specialty crops include fruits and vegetables, tree nuts, dried fruits, and horticulture and nursery crops, including floriculture. Get more details at www.agri.idaho.gov. Conservation Reserve Program

Expiring CRP Contract Options

If your CRP contract is expiring this year all or a portion of your expiring general signup CRP contract may be eligible to be re-enrolled into a new 10 to 15 year continuous contract provided the current contract is in full compliance and meets all eligibility criteria for continuous CRP. Some of the practices available under the continuous CRP program are: Field Windbreaks, Grass waterways, Shelterbelts, Filter strips and Riparian buffers among others. FSA encourages CRP participants with General Signup contracts expiring Sept. 30, 2009 to visit their local FSA office to get more information on the program.

Mid-management Practices

The purpose of mid-contract management activities is to enhance the wildlife habitat value of the enrolled acres by encouraging a diverse community and controlling noxious weeds and other invasive species. An integrated, adaptive management approach will help rejuvenate deteriorating CRP lands in order to increase community diversity and improve cover and food sources, benefiting wildlife and soil and water resources. All CRP contracts starting with sign up 26 are required to complete a mid-management practice during the life of the contract.

FSA offers 3 to 5 Year Limited Extensions

On May 1, Secretary Vilsack announced that certain CRP participants with CRP contracts that are scheduled to expire on September 30, 2009 may modify all or part of that contract to extend the expiration date for a period of 3 or 5 years at the same per acre payment rate. If you received a letter from the Secretary of Agriculture with an offer to extend your CRP contract 3 to 5 years the deadline to signup is June 30, 2009. Please make sure you come into the office and modify your conservation plan.

HELWC Violations

HELWC violators who do not receive COC's Good Faith exemption with approval by SED and technical concurrence from the State Conservationist shall remain ineligible for USDA program benefits for the years in violation. All HELWC violators that have been provided relief are subject to a graduated payment reduction (GPR) penalty. The amount of GPR will be based on the seriousness of the violation determined by using the number of acres in violation, the associated erodibility index (EI), and the actual soil loss. GPR's for HELC violations are from \$13 - \$500 per acre or a minimum of \$1,000 and a maximum of \$10,000.
