County Committee Election Results

COC election results for the Flemingsburg Service Center for Local Administrative Area 2, which consists of Flemingsburg, Mt. Carmel, Foxport and Beechburg areas were as follows. June Lee was elected to serve for a 3 year term with 97 votes and Robert List was elected as first alternate with 25 votes. This is the first time that a woman has been elected to serve on the Fleming County Committee. Mrs. Lee had previously served as Advisor to the County Committee.

Local Administrative Area 4 which consists of Cranston, Elliotville and Morehead reelected Joseph Fraley to a 3 year term with 36 votes and John Ingle was elected as first alternate with 1 vote.

Committee Nominations Open: Nominations are being accepted for candidates to run for the Farm Service Agency county committee election representing producers in Local Administrative Areas (LAA) 1 and 5. Elections are held each year to elect or re-elect a member(s) whose term will expire.

Flemingsburg Service Center will be holding an election for a person to represent the following Local Administrative Areas (LAAs) beginning January 1, 2011. LAA1 – This position is currently held by Ricky Barber. **LAA 1** includes the areas of Hillsboro, Grange City, Muses Mills and Plummers Landing in Fleming County. **LAA5** includes the areas of Farmers, Clearfield and Sharkey in Rowan County. LAA5 is currently represented by Dennis Perry who has served 3 terms and will not be eligible for reelection.
