Including all farms on the west side of the line and running south down to Shoemaker Ridge Rd.; thence down Shoemaker Ridge Rd. to the north fork of the river; and following the river to KY Hwy 2016 to St Helens –Dunagin Branch Rd. and then to the Owsley Co. line.
