County Committee Election Results: Last fall voters in Local Administrative Area (LAA) number 3 elected Paul Phillip Stamm to serve as their representative on the Lewis/Greenup Area FSA Committee. Paula C. Franke was elected as first alternate. In LAA 3, six hundred and seventeen voters were eligible to vote. Only ninety nine ballots were cast in which Paul Phillip Stamm received eighty five votes and Paula C. Franke received seven votes. Bradley Henderson also received one vote. Out of the ninety nine ballots cast, ninety three were counted and a total of four were invalid and two were spoiled. Congratulations to Phillip and Paula and thank you for serving your area!

At the first meeting in January, the Area FSA Committee elected Joseph M. Mauk to serve as Chairperson and Roger Bellew to serve as Vice Chairperson for 2010.

2010 Committee Elections: This year LAA 2 which is currently represented by Allen Richmond and LAA 4 which is currently represented by Roger Bellew will be holding elections.

LAA boundaries: **LAA 2** is the north and southeastern part of Lewis County. Southwest to Mill Branch to Route 59, south along Briery Creek, south and southeast to Rowan, Carter and Greenup County lines. **LAA 4** is the southern and eastern part of Greenup County. White Oak Rd to Load on Route 7, south to Route 2 to Raccoon east to Route 1459, east to Argillite on Hwy 207, north along Route 1 to Ohio River, east to Boyd County line, south to Carter County Line.
