Congratulations to Allen Schimpf! Allen was re-elected to represent farmers from Chatfield, Cranberry, Auburn, Texas, and Lykens on the county committee. Allen was elected to his 3rd consecutive term. The election results for Local Administrative Area [1] are:

FSA appreciates all of the voters for taking the time to complete the election ballot. The county committee system works only because of your participation.

The committee members held their organizational meeting on December 12, 2011 to determine who will serve as the county committee chairman and vice-chairman. Chairman for 2012 will be Steve Miller and vice chairman will be Rick Niese. The Committee will meet on the second Tuesday of the month at 8:30 am in the FSA office.

LDPs for Wool and Unshorn **Lamb Pelts**

Eligible producers have until Jan. 31, 2012, to apply for Loan Deficiency Payments (LDP) for wool and unshorn pelts produced during the 2011 crop year.

Eligible producers must have beneficial interest in the wool and pelts, owned the lamb for at least 30 calendar days before the date of slaughter and sell the unshorn lamb for immediate slaughter. Producers must also comply with wetland conservation and highly erodible land conservation Highly Erodible Land and provisions on all lands they operate or have interest in.

To qualify for payment, pelts must have been produced by an eligible producer from live unshorn lambs of domestic origin in the United States.

Faxed Signatures

Certain faxed signatures shall be accepted for all applicable program forms or other documents approved for faxed signatures, if all other signature requirements are met.

Applications for FSA Loans

Farmers that intend to apply to the Farm Service Agency for loan assistance for the upcoming crop year are encouraged to file their applications as early as possible. Filing early will help ensure that your loan is processed and approved as early as possible so that planting decisions can be made. Not applying early can result in a delay in processing loans due to the volume of applications that must be processed in date order. Contact your local FSA Loan Approval Official for more details and assistance in applying.

Wetland Conservation Compliance

Landowners and operators are reminded that in order to receive payments from USDA, compliance with Highly Erodible Land (HEL) and Wetland Conservation (WC) provisions are required. Farmers with HEL determined soils are reminded of tillage, crop residue, and rotation requirements as specified per their conservation plan. Producers are to notify the USDA Farm Service Agency prior to conducting land clearing or drainage projects to insure compliance. Failure to obtain advance approval for any of these situations can result in the loss of eligibility and all Federal payments.

Appeal Process

After an FSA official makes a decision on your request for USDA services or application, you will be sent a letter informing you of the decision and options your can pursue if you disagree.

Generally, program participants have three choices — an informal review with the original agency decision-maker, an opportunity for mediation and finally an appeal to the next level of authority within the agency.

County Committee Minority Advisors

FSA County Committee (COC) Advisors are a valued voice for under-represented groups and socially disadvantaged farmers and ranchers. County committee members and their county executive directors, actively reach out to producer groups who are under-represented on county committees.

Eligibility requirements for COC Advisor nominee include:

- be actively participating in farming or ranching in the county or area;
- be willing and available to serve as an advisor, if appointed; and
- indicate in writing their willingness to serve.

Duties and Responsibilities of COC Advisors include:

- attend each COC meeting, including executive sessions;
- participate in all deliberations;
- increase awareness of and participation in FSA activities, including elections, by eligible voters to ensure that socially disadvantaged group problems and viewpoints are understood and considered in FSA actions;
- help to develop interest and incentives in socially disadvantaged group members for considering FSA work as a career;
- active soliciting candidates from socially disadvantaged groups for nomination during the election process; and
- able to perform special duties at COC s request.
- Note: Advisors do not have authority to sign documents.

Interested individuals should submit a written letter that outlines their abilities and qualifications, as well as their willingness to serve, postmarked by Jan. 23, 2012. The Crawford County Committee will review these submissions and recommend a minority advisor to the Ohio FSA State Committee. The Ohio FSA State Committee will appoint the minority advisor, whose term will begin March 1st, 2012.

County Committee advisors serve for a 12-month period not to exceed 9 consecutive years.

Financial Inquiries for FSA Producers

January signals the beginning of a new year, and a time to gather financial records and start thinking about filling out a 1040. Producers who have signed up for a USDA eAuthentication Level 2 account will be able to access their farm data through Financial Inquires for FSA Producers. The site is available under Online Services on the Ohio FSA webpage at http://www.fsa.usda.gov/oh.

If you need to inquire about a particular electronic deposit, program payment, debt, or 1099G – USDA Level 2 customers can go here to view financial information.

Foreign Buyers Notification

The Agricultural Foreign Investment Disclosure Act (AFIDA) requires all foreign owners of U.S. agricultural land to report their holdings to the Secretary of Agriculture. The Farm Service Agency administers this program for USDA.

All individuals who are not U.S. citizens, and have purchased or sold agricultural land in the county are required to report the transaction to FSA with 90 days of the closing. Failure to submit the AFIDA form (FSA-153) could result in civil penalties of up to 25 percent of the fair market value of the property. County government offices, Realtors, attorneys and others involved in real estate transactions are reminded to notify foreign investors of these reporting requirements.

Special Accommodations

Special accommodations will be made upon request for individuals with disabilities, vision impairment or hearing impairment. If accommodations are required, individuals should contact the county FSA office staff directly or by phone.

Controlled Substance

Any person who is convicted under federal or state law of a controlled substance violation could be ineligible for USDA payments or benefits. Violations include planting, harvesting or growing a prohibited plant. Prohibited plants include marijuana, opium, poppies and other drug producing plants.

Hispanic and Women Farmers

A process to resolve the claims of Hispanic and women farmers and ranchers who believe they were discriminated against when seeking USDA farm loans has been established.

If you believe that the United States Department of Agriculture (USDA) improperly denied farm loan benefits to you between 1981 and 2000 because you are Hispanic, or because you are female, you may be eligible to apply for compensation.

USDA cannot provide legal advice to potential claimants. Persons seeking legal advice may contact a lawyer or other legal services provider.

Pigford Settlement Claims Filing Period Open for African American Farmers and Ranchers

Agriculture Secretary Tom Vilsack would like to remind African American farmers and ranchers that the period to file a claim in the Pigford II settlement has opened. African American farmers and ranchers who believe they are entitled to compensation under the Pigford II settlement must file a claim within 180 days in order to receive cash payment or loan forgiveness.

In February, USDA and Department of Justice announced an agreement with African American farmers to settle the Pigford II litigation for \$1.25 billion. Congress passed the Claims Resolution Act of 2010 that funded the settlement in November 2010, and the bill was signed by President Obama in December 2010.

The settlement arises from a class action lawsuit against USDA that alleges the Department discriminated against African-Americans who applied for or attempted to apply for farm loans or other farm benefits between January 1, 1981 and December 31, 1996. The settlement applies only to African-American farmers who meet specific eligibility requirements, including the requirement that they previously submitted a request to file a late claim in

the 1999 Pigford I class action Consent Decree.

The filing period opened November 14, 2011, and continues for 180 days, until May 11, 2012.

Claimants must register for a claims package (by calling the number or visiting the website) and the claims package will be mailed to claimants. 2012 DCP/ACRE Sign-up

2012 Direct and Counter-Cyclical Program (DCP) and ACRE enrollment will begin Jan. 23, 2012 and will end June 1, 2012. Here are some IMPORTANT REMINDERS:

- All producers with an interest in a crop on DCP base acres must be identified on the DCP/ACRE contract and receive a proportionate share of DCP/ACRE payment for the farm.
- Changes on the farm after enrolling June 1st in DCP/ACRE must be reported to your local FSA office such as:
 - o Ownership changes
 - o Producer changes (Individuals and Entities)
 - o Change in crop shares arrangements

Note: Changes cannot be made after Sept. 30, 2012.

Farming Operation Changes

If you have bought or sold land, or if you have added or dropped rented land from your operation, make sure you report the changes to the office as soon as possible. You need to provide a copy of your deed or recorded land contract for purchased property. Failure to maintain accurate records with FSA on all land you have an interest in can lead to possible program ineligibility and penalties. Making the record changes now will save you time in the spring. Update signature authorization when changes in the operation occur. Producers are reminded to contact the office of a change in operations on a farm so that records can be kept current and accurate.

Power of Attorney

FSA has a <u>required</u> power of attorney form available for those who find it difficult to visit the county office personally because of work schedules, distance, health, etc., that enables the participant to designate another person to conduct his or her business at the office. This can be done by completing an FSA-211, Power of Attorney. The form is available at your local USDA Service Center or online at:

Supplemental Revenue Assistance Program (SURE)

The sign-up for 2010 losses runs through **June 1, 2012.**

The Supplemental Revenue Assistance Program (SURE) provides benefits for farm revenue losses due to natural disasters that incurred in the crop year 2010. SURE is available to eligible producers on:

- Farms in counties with Secretarial disaster declarations, including contiguous counties, that have incurred a 10% loss including crop production, quality losses, for all crops grown by a producer nationwide, except grazed crops.
- Any farm in which, for the crop year, the actual production on the farm because of disaster-related conditions is 50 percent or less than normal production of the farm.

Eligible producers who suffered losses during the 2010 crop year are encouraged to visit their local FSA office to learn more about the SURE program. FSA also has SURE information available at www.fsa.usda.gov/sure.

Bank Account Changes

Current policy mandates that FSA payments be electronically transferred into your bank account. In order for timely payments to be made, producers need to notify the FSA county office if your account has been changed or if another financial institution purchases your bank. Payments can be delayed if the FSA office is not aware of updates to your account and routing numbers
