DCP Sign-up Continues

Enrollment for the 2011 Direct and Counter-cyclical Program (DCP) continues through **June 1, 2011**. USDA encourages producers to make use of the eDCP automated website to sign-up, or producers can visit any USDA Service Center to complete their 2011 DCP contract. USDA may accept any late-filed applications received through September 30, of the program year with approval authority by the county office, if filed before August 1, 2011.

Electronic DCP (or eDCP) service saves time, reduces paperwork and speeds up processing at USDA Farm Service Agency (FSA) offices. It is available to all producers who are eligible to participate in the DCP Program and can be accessed at: www.fsa.usda.gov/dcp Click on "Access eDCP Services" link, under "I Want to Section". To access the service, producers must have an active USDA eAuthentication Level 2 account, which requires an online registration form at: <http://www.eauth.egov.usda.gov> Click on "Create an Account Page" link, and lastly, visit to the local FSA Service Center for identity verification. Adjusted Gross Income

USDA has a Memorandum of Understanding with Internal Revenue Service to establish an electronic information exchange for verifying compliance with adjusted gross income (AGI) provisions for farm programs. Written consent will be required from each producer or payment recipient for the tax review process. No actual tax data will be included in the report that IRS sends to FSA. The agreement ensures that payments are not issued to producers whose AGI exceeds certain limits. The limits set in the 2008 Farm Bill are \$500,000 nonfarm average AGI for commodity and disaster programs; \$750,000 farm average AGI for direct payments; and \$1 million nonfarm average AGI for conservation programs.

Program participants subject to average AGI rules must submit form CCC-927 (Individual) and/or CCC-928 (Legal Entity) to the Internal Revenue Service by **June 15** to avoid interruption of program benefits.

Final Loan and LDP Availability Date

Producers are reminded that the final commodity loan and LDP availability date for 2010 Crop Year Corn, Dry Peas, Grain Sorghum, Lentils, Mustard Seed, Safflower Seed, Small Chickpeas, Soybeans and Sunflower seed **will be May 31, 2011**.

Farm Record Changes

FSA needs operators and owners to promptly provide notification about changes to your farm records for the 2011 crop year. If you are changing your operation entity type, adding or dropping cropland or farms, or adding entities to your operation, please contact the FSA county office. For reconstitutions, the deadline is August 1, 2011.

Special Accommodations

Special accommodations will be made upon request for individuals with disabilities, vision impairment or hearing impairment. If accommodations are required, individuals should contact the county FSA office staff directly or by phone at 419-294-2127.

2011 FSA County Committee Elections

Election of agricultural producers to Farm Service Agency (FSA) county committees is important to ALL farmers and ranchers, whether beginning or long-established, with large or small operations. It is crucial that every eligible producer participate in these elections because FSA county committees are a grass roots link between the agricultural community and the U.S. Dep't. of Agriculture.



Wyandot County Farm Service Agency is looking for individuals interested in serving on the County Committee. This year LAA-2 will be having an election. LAA-2 is comprised of townships: Richland, Salem Crane and Eden. Any eligible person residing in one of these townships who is interested in running for County Committee, or would like to nominate an individual to run for County Committee, must complete a nomination form. The Nomination form for County FSA Committee Election (FSA-669A) is available at Wyandot County FSA office. Members of socially disadvantaged groups (a group whose members have been subjected to racial, ethnic, or gender prejudice because of their identity as members of a group without regard to their individual qualities) are strongly encouraged to complete the Nomination Form for County FSA Committee Election (FSA-669A) and nominate themselves or another candidate.

Committee members make decisions on applications for federal farm program and disaster payments and play a vital role helping local farmers manage financial stress and natural disasters. Committee members make many other important decisions that affect local farmers such as whether haying and grazing should be allowed on Conservation Reserve Program acreage.

Nomination period begins June 15th and runs until August 1, 2011. Nomination forms for 2011 election must be postmarked or received in the FSA office by close of business on Aug. 1, 2011.

Ballots will be mailed to eligible voters November 4th and must be returned by December 5, 2011. The elected Committee Member and Alternates will take office January 1, 2012.

Currently serving on our committee are incumbent for LAA #2, Jerry Murphy- Chairperson, Chuck Bigler – Vice Chair, Jim Kin – Member, & Connie Iles – Advisor.

2009 SURE Sign-up Continues

The sign-up period for the 2009 crop year Supplemental Revenue Assistance Payments (SURE) program continues **until July 29, 2011**. SURE provides benefits for 2008 - 2011 crop year farm revenue losses due to natural disasters. USDA encourages producers who suffered losses during the 2009 crop year to visit their local FSA office to learn more about the SURE program.

To be eligible for SURE a farm must have:

- At least a 10 percent production loss on a crop of economic significance;
- A policy or plan of insurance under the Federal Crop Insurance Act or the Noninsured Crop Disaster Assistance Program (NAP) for all economically significant crops;
- Been physically located in a county that was declared a primary disaster county or contiguous county by the Agriculture Secretary under a Secretarial Disaster Designation. Without a Secretarial Disaster Designation, individual producers may be eligible if the actual production on the farm is less than 50 percent of the normal production on the farm due to a natural disaster. Producers considered socially disadvantaged, a beginning farmer or rancher, or a limited resource farmer may be eligible for SURE without a policy or plan of insurance or NAP coverage.

2010 ACRE Program Production Reports

Producers that participated in the ACRE program for 2010 are required to report 2010 production for use in computing 2010 ACRE payments, if applicable, and 2011 benchmark farm yields. The reporting deadline date for 2010 production reports is **July 15, 2011** for small grains and other crops. Production reports may be submitted by the 2010 crop year operator, owner or other producer with an interest in the reported acreage. Failure to file a production report (FSA-658) for a farm enrolled in ACRE will result in the farm's producers being ineligible for any ACRE contract payments and the actual yield used to determine future benchmark farm yields will be zero.

When Weather Prevents or Damages Crops

When bad weather prevents planting or damages crops, Vicki Orians, County Executive Director for the Farm Service Agency (FSA) would like to remind producers to report the acreage to the FSA office within 15 days of the final planting date of the crop. This applies to all crops, whether covered by crop insurance, not covered by insurance, or covered by FSA's Non-insured Assistance Program (NAP). Final planting dates vary among counties and crop types.

Producers who have their crops insured through a private crop insurance company should contact the insurance agent immediately and advise them of the damaged crops. Additionally, a *CCC-576, Notice of Loss Application*, must be completed at the FSA office, and the prevented or failed acres reported.

For those crops covered under FSA's NAP, producers should immediately contact the FSA office to report the acres and file a *CCC-576, Notice of Loss Application*. "Producers with NAP coverage should report their losses within 15 calendar days of crop damage from natural disaster, so the loss can be appraised and production counted before the crop is put into another use, abandoned or destroyed," said Orians.

Crops not covered with a private insurance or NAP policy should still be reported to the local FSA office, and producers should file a Notice of Loss Application. This will provide FSA with a historical record of your crop should disaster assistance become available.

USDA Continues Process to Resolve Discrimination Claims of Hispanic and Women Farmers

As part of continued efforts to close the chapter on allegations that discrimination occurred at USDA in past decades, USDA established a process to resolve the claims of Hispanic and women farmers and ranchers who assert that they were discriminated against when seeking USDA farm loans.

The claims process offers a streamlined alternative to litigation and provides at least \$1.33 billion in compensation, plus up to \$160 million in farm debt relief, to eligible Hispanic and women farmers and ranchers. Individuals interested in participating in the claims process may register to receive a claims package, or may obtain more information, by visiting www.farmerclaims.gov.

Individuals can register to receive a claims package by calling the Farmer and Rancher Call Center at 1-888-508-4429. USDA cannot provide legal advice to potential claimants. Persons seeking legal advice may contact a lawyer or other legal services provider.

Reporting Crop Acreage

Please remember that filing an accurate acreage report for all crops and land uses, including failed acreage and prevented planting acreage, can prevent the loss of benefits for a variety of programs.

Failed acreage must be reported within 15 days of the disaster event and before disposition of the crop. Prevented planting must be reported no later than 15 days after the final planting date.

Acreage reports are required for many Farm Service Agency programs. For crops other than Noninsured Crop Disaster Assistance Program (NAP) crops, acreage reports are to be certified by the June 30 deadline on small grains and a July 15 deadline on all other crops.

Acreage reports on crops for which NAP assistance may be paid are due in the county office by the earlier of June 30 for small grains and July 15 for all other crops, or 15 calendar days before the onset of harvest or grazing of the specific crop acreage being reported. Producers are encouraged to visit their local FSA county office to file the required FSA-578 certification report before the deadline dates expire. Filing an accurate acreage report for all crops and land uses, including failed acreage and prevented planting acreage, can prevent the loss of benefits for a variety of programs.

Farm Loans for Socially Disadvantaged

Vicki Orians, Executive Director of the Wyandot County FSA office reminds interested applicants that FSA offers loans for farmers to purchase farmland and finance agricultural operations. FSA loan programs are designed to help producers who are temporarily unable to obtain private or commercial credit. In many cases, applicants are beginning farmers who have insufficient net worth to qualify for financing through a commercial lender. In other instances, applicants might have suffered setbacks from natural disasters or might be persons with limited resources.

FSA makes two different types of loans, direct and guaranteed. Farm ownership loans or farm operating loans may be obtained as direct loans for a maximum of up to \$300,000. Guaranteed loans (loans made by a commercial lender where FSA acts as guarantor) can reach a maximum indebtedness of \$1,119,000. Emergency loans are a type of direct loan for farmers who may have suffered physical or production losses in disaster areas designated by a Presidential or Secretarial disaster declaration. Rural Youth Loans, Loans to Beginning Farmers and loans for Socially Disadvantaged Applicants are other types of direct loans also available through FSA.

Socially Disadvantaged Applicants (SDA) are one of a group whose members have been subjected to racial, ethnic or gender prejudice because of their identity as a member of the group without regard to their individual qualities. SDA groups are Women, African Americans, American Indians, Alaskan Natives, Hispanics, Asian Americans and Pacific Islanders. Certain FSA loan funds are targeted to beginning farmers and SDA.
