

It's county committee election time, and this special publication is your guide to the 2009 election.

Since this only happens once a year, here is an election refresher. For election purposes, counties are divided into local administrative areas, or LAAs. Each LAA contributes one producer to serve a three-year term on the Farm Service Agency county committee.

Natrona County is divided into 3 LAA's and Converse County is divided into 2 LAA's. (See Map on the back)

Each year, an election is held in an LAA to replace the committee member whose three-year term is expiring. This year LAA 2 is up for reelection. LAA 2 is currently held by Mary Owens. Mary has served on the County Committee for 9 years and is ineligible for reelection. Therefore, we are seeking nominations for LAA 2.

The County Committee member that serves LAA 2 represents all farmers and ranchers north of Interstate 25 east of Casper and north of U.S. Highway 20 west of Casper. (See Map on back)

The three steps in the election process are the call for nominations, the election and installing the new committee member.

Election Timetable

June 15	Nomination period begins.
Aug. 3	Deadline to submit nomination forms.
Nov. 6	Ballots are mailed to eligible voters.
Dec. 7.	Deadline to return completed ballots.
Jan. 1, 2010	New committee members and alternates are installed.

Nominations Open June 15

Nominations for candidates to run for the Farm Service Agency county committee election representing producers in a Local Administrative Area will be accepted from June 15 through Aug. 3, 2009.

Producers who are residents in the LAA holding the election and who participate or cooperate in an FSA program and are of legal voting age may be nominated to serve on the county committee.

Individuals may nominate themselves or others as candidates. Also, organizations representing socially disadvantaged minorities and women farmers or ranchers may also nominate candidates.

A nomination form, FSA-669A, is included in this newsletter. Additional forms and details may be picked up at the county office or downloaded from the FSA Web site. Simply go to <http://www.fsa.usda.gov>

Eligible voters can nominate as many candidates as they wish. To be valid, the nomination form must be signed by the person being nominated, indicating agreement to serve if elected, and returned to the FSA county office by the close of business on Aug. 3, or postmarked by midnight Aug. 3.

The county committee election is held by mail. Ballots will be mailed to eligible voters beginning Nov. 6, and must be returned to the FSA county office by the close of business on Dec. 7, or postmarked by midnight Dec. 7, 2009.

Who Can Vote

Agricultural producers of legal voting age can vote if they participate or cooperate in any FSA program. A person who is not of legal voting age but supervises and conducts the farming operations on an entire farm can also vote.

No one can be denied the right to vote because of race, color, national origin, sex, religion, age, disability, political beliefs, sexual orientation or marital or family status. If you are unsure of your eligibility, contact the staff at the county office.

Who Can Hold Office

To hold office as a county committee member, a person must meet the basic eligibility criteria.

- Participate or cooperate in a program administered by FSA
- Be eligible to vote in a county committee election
- Reside in the LAA in which the person is a candidate
- Not have been:
 - Removed or disqualified from the office of county committee member, alternate or employee
 - Removed for cause from any public office or have been convicted of fraud, larceny, embezzlement or any other felony
 - Dishonorably discharged from any branch of the armed services.

 - C. Willing to serve if elected.
- ITEM 2** Enter the nominee's current address.
- ITEM 3** The nominee must check one of the boxes to indicate a preference regarding the settling of tied votes.
- ITEM 4** The nominee must sign and date.
- ITEM 8** Completing this item is voluntary.


ALL FORMS MUST BE RECEIVED IN THE COUNTY OFFICE OR POSTMARKED BY AUGUST 3.

NOTE: *The following statement is made in accordance with the Privacy Act of 1974 (5 USC 552a) and the Paperwork Reduction Act of 1995, as amended. The authority for requesting the following information is 7 CFR Part 7. The information will be used to obtain nominees for County FSA Committee.*
