1	LAA 1: The boundaries for the LAA 1 is the area North of Fallon county with the Wibaux County line being the north boundary, the North Dakota line being the east boundary, the west boundary runs six (6) miles west of Highway 7 from the north Wibaux County line and then 13 miles south; 2.5 miles west; then 12 miles south at this point the southern boundary is established by going 17 miles east to the North Dakota border.	316
2	LAA 2: The boundaries for LAA 2 is the southern border of LAA 1 being the northern boundary for LAA 2, the North Dakota line being the east boundary, the west boundary runs from the south west corner of LAA 1 and goes south for 3 miles and then progresses west for 11 miles and then turns south for nine miles to the Carter County line, the southern border for LAA 2 is the Carter County line.	291
3	LAA 3: The boundaries for LAA 3 for the northern border starts at the west boundary of LAA 1, using the Wibaux County line and the Prairie County line for the northern border, and uses the westerly boundary of LAA1 and LAA2 to establish the eastern border, the western border is the Custer County line and the southerly border is the Carter County line.	299


