

East Boundary is Daniels/Sheridan County border. West boundary starts from the most northern point of where T37 R49 Section 4 and T37 R49 Section 5 Meet (on the US/Canada border) and runs directly south following the section lines for 30 miles until the most southern point of where T33 R49 Section 34 and T33 R49 Section 35 meet on the Daniels/Roosevelt County Boundary. The north boundary starts at the most northern point of where T37 R49 Section 4 and T37 R49 Section 5 Meet (on the US/Canada border) and runs east following the US/Canada border until Sheridan County. South boundary starts at the most south point where T33 R49 Section 34 and T33 R49 Section 35 meet on the Daniels/Roosevelt County Boundary and follows the county line east until Sheridan County.

LAA2

West Boundary is Daniels/Valley County border. East boundary starts from the most northern point of where T37 R47 Section 2 and T37 R47 Section 3 Meet (on the US/Canada border) and runs directly south following the section lines for 30 miles until the most southern point of where T33 R47 Section 36 and T33 R48 Section 31 meet on the Daniels/Roosevelt County Boundary. The north boundary starts at the most northern point of where T37 R49 Section 4 and T37 R49 Section 5 Meet (on the US/Canada border) and runs west following the US/Canada border until Valley County. South boundary starts at the most south point where T33 R47 Section 36 and T33 R48 Section 31 meet on the Daniels/Roosevelt County Boundary and follows the county line west until Valley County.

LAA3

West boundary starts from the most northern point of where T37 R47 Section 2 and T37 R47 Section 3 Meet (on the US/Canada border) and runs directly south following the section lines for 30 miles until the most southern point of where T33 R47 Section 36 and T33 R48 Section 31 meet on the Daniels/Roosevelt County Boundary.

East boundary starts from the most northern point of where T37 R49 Section 4 and T37 R49 Section 5 Meet (on the US/Canada border) and runs directly south following the section lines for 30 miles until the most southern point of where T33 R49 Section 34 and T33 R49 Section 35 meet on the Daniels/Roosevelt County Boundary.

The north boundary starts at the most northern point of where T37 R47 Section 2 and T37 R47 Section 3 Meet (on the US/Canada border) and runs east following the US/Canada border (10 miles) until it reaches the most northern part of where T37 R49 Section 4 and T37 R49 Section 5 Meet (on the US/Canada border).


The south boundary starts at the most south point where T33 R47 Section 36 and T33 R48 Section 31 meet on the Daniels/Roosevelt County Boundary and follows the county line east (10 miles) until it reaches the most southern part where T33 R49 Section 34 and T33 R49 Section 35 meet on the Daniels/Roosevelt County border

T37 R49 Section 4 and T37 R49 Section 5 Meet (on the US/Canada border) and runs west following the US/Canada border until Valley County. South boundary starts at the most south point where T33 R47 Section 36 and T33 R48 Section 31 meet on the Daniels County/Roosevelt County Boundary and follows the county line west until Valley County.
