## LAA Boundary Descriptions

LAA1 North of Highway 12 at the Musselshell/Rosebud County line to the Yellowstone River Bridge. North of Yellowstone River at the bridge to Rosebud Creek Road. East of the Rosebud Creek Road at the Yellowstone River to the Northern Boundary of the Northern Cheyenne Tribe Reservation. All land north of the Northern Cheyenne Reservation extended east to Powder River County Line.

LAA2 South of Highway 12 at the Musselshell/Rosebud County line to the Yellowstone River Bridge. South of Yellowstone River at the bridge to Rosebud Creek Road, west of the Rosebud Creek Road at the Yellowstone River Bridge to the Northern Boundary of the Northern Cheyenne Tribe Reservation.

LAA3 All land south of the Northern Boundary of the Northern Cheyenne Tribe Reservation. Extended east to Powder River County Line.


LAA4 Within the boundaries of Treasure County – all land south of the Santa Fe Burlington Northern Railway.

LAA5 Within the boundaries of Treasure County – all land north of the Santa Fe Burlington Northern Railway.
